CHAPTER 1. REQUIREMENTS FOR SPORTS FACILITIES

Article 1. General Requirements for Sports Facilities

1. Club teams whose “home” Games are held at Sports Facilities compliant with these Regulations are admitted for participation in the Championship.
2. Sports Facilities selected for Championship Games must be completed and accepted by the government commission before the Championship start date, obtain permissions for operation, and comply with the requirements of the Rule Book of the Hockey Game.
3. Sports Facilities selected for the Championship Games must comply with the “Requirements for certain infrastructure objects of sports facilities for official sports competitions and technical equipment of stadiums to ensure public order and safety” approved by Order No. 1092 of the Ministry of Internal Affairs of Russia dd. November 17, 2015 in accordance with the Decree No. 353 of the Government of the Russian Federation “On the approval of Rules for ensuring safety during official sports competition” dd. April 18, 2014 (for Russian clubs only).
4. Sports Facilities selected for the Championship Games must obtain the following documents:
 - 1) certificate registered by a government body on physical training and sports of the respective subject of the Russian Federation pursuant to a standard form approved by Order No. 117 of the State Committee of the Russian Federation for Physical Education and Tourism “On certification and non-recurring registration of sports facilities” dd. April 8, 1996 (for Russian Clubs only);
 - 2) safety certificate of a Sports Facility in accordance with the Decree of the Russian Government No. 202 “On approval of requirements for anti-terrorism security of sports facility and form of the security certificate of sports facilities” dd. March 6, 2015, Instruction on ensuring public security at a sports facility during official sports competitions, Action plan on measures to ensure public order and security at a sports facility during official sports competitions approved by Order No. 948 of the Ministry of Sport of the Russian Federation dd. November 26, 2014 (for Russian Clubs only).
5. Sports Facilities must be included in the All-Russian register of sports facilities (for Russian Clubs only).
6. Sports Facilities selected for “home” Championship Games by foreign KHL Clubs must obtain the Sports Facility passport or a similar document registered in accordance with their national laws.
7. Ownership rights with respect to Sports Facilities selected for the Championship Games must be registered in the Unified State Register of Property Rights and Transactions before the Championship start date. Foreign Sports Facilities must obtain registered documents confirming the respective ownership rights in accordance with their national laws.
8. On an annual basis, Employees supporting the activities of the respective services of the Sports Facility must read and acknowledge in writing the following documents before August 1 (for Russian Clubs only):
 - a) Order No. 44 of the Committee of the Russian Federation for Physical Education and Sports “On ensuring safety and prevention of injuries related to physical training and sports” dd. April 1, 1993;
 - b) Order of the Committee for Physical Education and Sports of the Council of Ministers of the USSR No. 786 “On introduction of the “Regulation on measures to ensure public order and security, as well as evacuation and alerting of participants and spectators during mass sports events”” dd. October 17, 1983; Decree of the Russian Government No. 353 “Rules for ensuring security during official sports events” dd. April 18, 2014;
 - c) Federal Law No. 192-FZ “On amendments to certain legislative acts of the Russian Federation in connection with ensuring public order and security during official sports competitions” dd. July 23, 2013.
9. Compliance with the requirements of the above-mentioned legislative acts must be ensured by the Sports Facility administration during any Games or other Championship events.

10. On an annual basis, each Sports Facility selected for Championship Games must obtain a certificate of readiness for operation from a specialized commission before August 1. Among other matters, the above-mentioned certificate must contain the commission's conclusion on reliability and stability of building structures and technical systems, compliance of spectator evacuation routes with specified standards, sports and engineering environment of future Games.

11. Before the Championship mandatory third-party liability of the hockey Games organizer must be covered (tenants, free-of-charge users of the Sports Facilities or owners of the Sports Facilities where Championship Games are to be held).
12. Each year before the Championship every Club must complete and forward to the League the Certificate of Compliance of the Sports Facility with the requirements of these Regulations signed by the Sports Facility director, Club director (Appendix 1 to the KHL Technical Regulations), as well as video image from all Video Goal System cameras.

13. No later than 4 hours before starting a Game, the Certificate of the Sports Facility readiness for the Championship Game must be completed (Appendix 2 to the KHL Technical Regulations). No later than 3 hours before starting a Game, the competition venue shall be inspected from the operational and technical point of view, and no later than 1 hour before starting a Game, the respective Inspection Report shall be completed and presented to the Chief Referee (Appendix 3 to the KHL Technical Regulations). The above-mentioned documents shall be stored for three (3) years after finishing the Championship.
14. When planning any constructive and technical modifications (reconstruction) of the Sports Facility at which the Club holds "home" Championship Games, the Club shall agree future modifications (reconstruction) with KHL in order to comply with the requirements of these Regulations and make it possible for KHL to reflect the respective modifications in the Database of Sports Facilities.
15. The designed (constructed) Sports Facility for Championship Games must fully comply with the requirements of these Regulations (together with Appendix 7 "Designed Sports Facilities" to the KHL Technical Regulations).
16. With respect to technical characteristics of the Sports Facility that affects the safety of sportsmen and spectators during a Game (safety netting, glass, board systems, ice preparation systems, air conditioning systems, lighting systems, etc.); KHL introduces requirements that are mandatory for Clubs participating in the Championship.

Article 2. The number of individual seats for spectators at Sports Facilities

1. The number of individual seats for spectators at a Sports Facility must be no less than five thousand and five hundred (5,500).
2. Clubs that are based in cities with a population of less than one hundred thousand (100,000) people are allowed to hold the Championship Games at Sports Facilities with a seating capacity of less than five thousand and five hundred (5,500) but no less than two thousand and five hundred (2,500) seats, and the Sports Facilities must comply with the remaining requirements to Sports Facilities set out in the KHL Technical Regulations.

Article 3. Requirements for the infrastructure of Sports Facilities

1. Each Sports Facility selected for the Championship Games must have the following infrastructure:
 - 1.1. Hockey rink equipped in accordance with the Rule Book of the Hockey Game with:
 - a) goal net with elastic locks with a total length of at least 20 cm and thin part length at least 12 cm fixed in special inserts in a concrete plate, and video cameras of the Video Goal System inside the goal net in white protective cases. Goal nets that are used during pregame

warm-up must comply with the requirements for goal nets that are used during the Game, except for Video Goal cameras. At the Sports Facility, game goals must be selected, as well as the goal net for pregame warm-up that are used during KHL Championship Games only. The goals must be free from damages, paint fractures and contamination on the frame, buffer stuffing and net damages and contamination. The goals must have a standard color based on the RAL 3020 table. The game goals must have white fixtures made of a polymer material to fix plastic water bottles on the upper rear part of central goal posts;

- b) strobes installed above the game goals on the ceiling of the Sports Facility or another lighting equipment regardless of its location that is installed to turn on and create lighting effect (impulse) when a goal is scored;
- c) shields made of safety glass/acryl behind the goal net and along the boards at least 160 cm high; taking account of the scheduled replacement of board systems, requirements of paragraph 4.1, clause 4, of Appendix 9 to the KHL Technical Regulations shall be applied;
- d) the safety glass/acryl shields must be coplanar along the entire board perimeter. Gaps between safety glass/acryl shields must be closed with inserts to the safety glass/acryl shield height along the entire perimeter of the hockey rink;
- e) replacement sections of the safety glass/acryl shield for prompt replacement in case of their breakage;
- f) safety shield with a canopy (if the height of the safety shield is not sufficient) made of safety glass/acryl behind the benches and at edges of Players' Benches and Penalty Boxes that separate Hockey Players on Players' Benches and in Penalty Boxes from spectators. The safety shield height and canopy construction must prevent contacts between Hockey Players, team representatives, Game officials and spectators, as well as appearance of items thrown from the grandstands to Players' Benches, Penalty Boxes and Game officials. Gaps must be closed with inserts to the safety glass/acryl shield height. No gaps between sections are allowed;
- g) safety glass/acryl shield (divider) between Players' Benches of both teams;
- h) high strength netting over the safety glass to separate spectators behind the goals from the hockey rink, at least 10 m high, tilted 80 grades with respect to the horizontal plane towards the grandstands;

- i) safety shield along ice hockey rink boards to protect advertisement boards;
- j) self-stick advertisement with silicone surface. It is also allowed to install media panels in the board systems on the rink side; each panel width must be the same as a single board section width. Layout and size of media panels shall be agreed with KHL;
- k) special cover to prevent injuries along the board perimeter on the hockey rink side and installed at the joint of the upper board edge with the safety glass/acryl shield for board systems with a width of more than 40 mm; safety stuffing for the entire glass height or a special rounding in gaps of the safety glass/acryl shield;
- l) high-quality ice surface prepared in compliance with Appendix 8 to the KHL Technical Regulations with clearly visible official marking in accordance with the Rule Book of the Hockey Game. Before the season start and prior to flooding the rink to form the ice surface KHL Hockey Clubs must agree with the Department of Competitions and CHL LLC a planogram of advertisement placement and/or other information on the ice surface to ensure its compliance with the Rule Book of the Hockey Game. KHL Hockey Clubs must ensure renewal of the hockey rink marking during Championship breaks and after the end of the Championship Stage One. The marking colors must comply with the RAL table (red — 3020, blue — 5005, light blue — 5012);
- m) A container for cooling pucks before the start of and during the Game;

- n) Deleted.

- o) A STM System installed by the KHL. The STM System equipment shall be synchronized with a Sports Facility countdown chronometer of the play time. The Club shall prevent, during the pre-game warm-ups and Games, placement of any items disturbing the operation of the STM System equipment, in particular, prevent placement of items between the locator and the ice rink, as well as between the STM System camera and the ice rink.

- 1.2. Requirements at the Sports Facilities where KHL Clubs hold “home” Games must be met with respect to board systems and stage-by-stage replacement of board systems (Appendix 9 to the KHL Technical Regulations).

- 1.3. National flags of Clubs participating in the Championship, KHL, FHR and Federal subjects of equal size located at a prominent place above the ice surface of the hockey rink of the Sports Facility. Forms, colors and the use of the national flags of Clubs participating in the Championship must comply with the laws of their respective countries.
- 1.4. At least two ice-resurfacing machines meeting modern technical requirements and subject to mandatory technical maintenance before the season start.
- 1.5. Scoreclock in accordance with the Rule Book of the Hockey Game. Exact and full name of the Championship must be visible on the scoreclock or at another noticeable location of the spectators seating. If displayed on the scoreclock, the Championship name must be demonstrated continuously or in the news ticker format during the Game. The text block must comply with the requirements of the KHL Marketing and Communications Regulations.
- 1.6. A technical device for making the audio signal (siren) connected to countdown chronometers in dressing rooms of teams and at the premises of Referee and Linesmen. The device is designed to inform about the countdown start, warm-up start and end, as well as appearance of teams on the hockey rink in the beginning of a Game and after intermissions (in accordance with the requirements of the KHL Sports Regulations).
- 1.7. At least two dressing rooms for Hockey Players equipped with comfortable furniture (chairs, tables, hangers, mirrors, stick racks, countdown chronometers, etc.), sufficient electric sockets, lighting of the uniform color temperature, ventilation system and a hockey rink mockup, two floor fans with a diameter of at least 40 cm. The dressing rooms must be equipped with wireless Internet access system (Wi-Fi supporting the WPA2 Personal network security technology). Network identifier and access password shall be set by technical specialists of the Sports Facility in compliance with KHL requirements presented one (1) month prior to each season start (and are displayed to Hockey Players). Each dressing room area must be at least 70 m², excluding auxiliary adjacent premises:

- a) shower stalls (wall mixers) in compliance with applicable construction standards and rules (at least five);
 - b) toilet cabins (at least three);
 - c) rooms for Coaches (area of at least 10 m²) equipped with comfortable furniture and hockey rink mockup, wireless Internet access system (Wi-Fi supporting the WPA2 Personal network security technology). Network identifier and access password shall be set by technical specialists of the Sports Facility in compliance with KHL requirements presented one (1) month prior to each season start (and are displayed to Coaches).

- d) massage rooms (area of at least 8 m²) equipped with two massage tables; it is also recommended to allocate a room for visiting team doctor;
 - e) driers for sports uniform;
 - f) storing rooms;
 - g) specifically prepared areas (near the dressing room) for hockey skate sharpening and other technical procedures equipped with sufficient electric sockets and an exhaust ventilation system;
 - h) driers properly certified by their manufacturer for 24 pairs of skates / gloves.
- 1.8. The sports area floor must be specifically covered to prevent damaging Hockey Players' skates.
- 1.9. A convenient seat on the grandstands at the center of the rink and conditions for video recording of the Games by visiting Club representatives, excluding the technical equipment required for the recording.
- 1.10. A separate room of a sufficient area for four (4) people — Chief Referees and Linesmen (for six (6) people during play-off). The room must be located as far as possible from dressing rooms of hockey teams and equipped with a ventilation system, shower, toilet, and provide for enough personal areas to change clothes (similar to personal areas for changing Hockey Players' clothes), hangers, a mirror, the rink mockup, TV set, a laptop connected to the TV set, wireless network coverage (Wi-Fi with WPA2 Personal, the network ID and password required for access shall be set by technical specialists of the Sports Facility in compliance with the KHL requirements sent 1 month prior to start of each season and then such network ID and password shall be put up in the above room for the Officials' information), countdown meter, telephone connection with the room of the Ice Arena Video Goal Judge, exercycles in working order (2 pcs.), exercise mats (2 pcs.). The following products and items shall be in the above room: bottled (still) water, energy drinks (isotonic drinks), coffee, tea, fruits, sandwiches, chocolate, shampoo, towels, shoe laces (4 pairs), insulating tape (white and transparent), pizza or sandwiches upon completion of the Game. Prior to start of the Game, the Club shall send a service-man to the above Officials' room to check that all listed above is in the room. Upon Chief Referee's request, the Club shall make it possible to view the recorded Game, including the recordings made by the Video Goal System cameras after the Game.

- 1.11. A room for the Officials' team to execute the Official Game Report equipped with the countdown timer, a laptop, printer, Internet access and means of communication to send the Official Game Report by electronic mail or fax to KHL.

- 1.12. Ten workplaces for Statistic Teams located at the top of central sectors of the grandstands on the Players' Bench side. The workplaces shall be equipped with desks and chairs, electric sockets, seven laptops provided by the Club for each Game, Internet connection at a speed of at least 1 Mbit/sec for each device. A wired connection must be used for Internet access. Redundant communication channels must be provided for Internet access. Wi-Fi can be used only as a redundant communication channel. Allocating the Statistic Team workplaces and different areas of the Sports Facility and (or) changing the location of workplaces during the season must be approved by KHL in writing.

- 1.13. A Statistic Team member workplace behind the Official's desk for direct text broadcasts via Internet to the KHL website with full view of the rink, Internet access with a guaranteed speed of at least 1 Mbit/sec, electric sockets, a desk and a chair. Redundant communication channels must be provided for Internet access and a laptop provided by the Club, as well as telephone or radio communication with all other workplaces of the Statistic Team.
As agreed with the KHL Statistics and Analytics Department, the Statistic Team member

workplace may be relocated for conducting live text broadcasts via the Internet to the KHL website.

1.14. The workplace of the KHL partner's Statistic Team member located next to the members of Statistic Teams equipped with a desk and a chair, electric sockets, Internet access with a guaranteed speed of at least 1 Mbit/sec for each connected device. A wired or Wi-Fi connection must be used for Internet access. Redundant communication channels must be provided for Internet access. Changing the location of a workplace of the KHL partner's Statistic Team member during the season must be approved by KHL in writing.

1.15. Designated locations for two teams of duty medical personnel and parking area for two ambulance vehicles for the entire period of the Game. Location of the duty medical personnel teams must be designated by a flag or banner (size: 30 x 40 cm) that must be visible from all spectators' seats. Medical personnel teams shall be located close to the rink, the storage area for medical equipment and maintenance gate for ice resurfacing machines, not higher than the second row of the Sports Facility grandstands. There shall be no obstacles along the route of the medical team to the rink during the Game.

1.16. Sports Facility Medical Station:

- a) shall be easy to approach by spectators and ambulance crews;
- b) shall have doors and passages of enough width to bring in stretchers or wheelchairs;
- c) shall be equipped with bright lighting, ventilation, heating, air-conditioning system, electrical sockets, cold and hot water, potable water, washbasin and toilet, internal and external telephone communications;
- d) shall be equipped in compliance with Appendix No. 8 to the Order of the Ministry of Health of the Russian Federation No. 134n "On the procedure of organizing the provision of medical aid to people engaged in physical training and sports (including preparation and holding of physical training and sports events), including the procedure for medical examination of people who want to be engaged in sports training, physical training or go in for sports at organizations and/or reach qualifying standards of tests within the scope of the All-Russian Physical and Sports Complex "Ready for Labor and Defense"" dated March 1, 2016. At the Sports Facilities where foreign KHL Clubs hold "home" Championship Games, the medical station must be equipped in compliance with the national legislation;
- e) shall provide qualified medical personnel working according to a pre-approved schedule.

1.17. Clear signs of direction to the Medical Station making it possible to use the shortest route to the Medical Station from any location at the Sports Facility.

1.18. Doping Control Station located close to the rink and Hockey Players' dressing rooms with necessary instruments for collecting samples from Hockey Players under control. Passage to the Station must be specifically covered to protect hockey skates. There must be a No Trespassing sign on the door of the Doping Control Station. Spectators and Mass Media Representatives shall not have access to the Doping Control Station. The Doping Control Station must be equipped in compliance with the requirements of the KHL Medical Regulations.

1.19. Designated seats at the stands (at least ten (10)) for disabled people and at least ten (10) seats for their accompanying persons ensuring barrier-free environment and the respective passages equipped with special appliances (ramps, elevators) for free movement and access of persons with disabilities related to supporting-motor system, using wheelchairs, as well as an equipped toilet cabin for this category of people, including a washbasin with a pedal-type mixer, a mirror above the washbasin located at the right height, hinged handrails at the flush toilet area, a paper tissue or towel container, open-type toilet paper holder or dispenser, a liquid soap container, a wastebasket. Height must be convenient for this category of people. External ramps must have

handrails taking account of technical requirements for stationary supporting devices. On the territory adjacent to the Sports Facility, there must be a designated parking area for at least ten cars transporting disabled people. Tickets for disabled spectators must meet the requirements of Chapter 2, Article 4, clause 4.9 of the KHL Club Ticket Service Regulations (Appendix 4 to the KHL Marketing and Communications Regulations).

1.22. Separate working premises for KHL representatives equipped with telephone and fax communications, a copying machine and computer with a printer, a TV set with an option to view direct broadcast of the Game. The computer shall be connected to the Internet.

1.23. A separate room with full view of the rink for the Ice Arena Video Goal Judge, Game Inspector, and Club technician at the top level of the Sports Facility. The room shall be equipped with the technical devices in accordance with Appendix 5 to the KHL Technical Regulations.

- c) a 22-inch monitor with the resolution of at least Full HD 1080p; 1920×1080; 16:9 installed on the officials' desk for viewing controversial events synchronized with the equipment in the Ice Arena Video Goal Judge and video cameras on blue lines (to implement the procedure of a detailed viewing upon a Coach's request, of Chief Officials' consultations and review of disputable situations in compliance with Article 87 of the KHL Sports Regulations);

- 1.26. An individual video camera for non-stop panoramic recording of the Game, including Players' Benches and Penalty Benches, from the moment when teams start the warm-up until the moment when teams leave the rink at the Game end. The recorded video shall be stored by the Club for 5 days after the respective Game and presented to KHL immediately upon request. The video camera shall support HD format and perform HD recording (technical parameters of the camera shall be agreed with the TV Project Department of CHL LLC prior to its purchasing).

- 1.27. Press Center for Accredited Mass Media Representatives — specifically allocated separate premises close to Mass Media areas equipped with the following:

- a) at least twenty (20) workplaces, and during the Championship Second Stage – at least thirty (30) workplaces equipped with extension cables for at least 2 electric sockets for one workplace;
(last updated on July 4, 2019. Minutes of meeting of CHL LLC Board of Directors No. 96 dated July 4, 2019)
- b) five (5) workplaces of the 20 workplaces shall be equipped with a wired Internet connection (including no less than 2-meter-long Ethernet cable with the RJ-45 connector for each workplace);
- c) two (2) TV sets with display size of at least 40 inches for viewing direct broadcast of the Game in case it is prepared;
- d) a multifunctional device (printer, copier and scanner) supporting color printing in A4 format from removable media, copying and scanning to the removable media; two (2) packs of A4 paper;
- e) a laptop or a desktop computer with Internet access (with a guaranteed outgoing stream speed of at least 50 Mbit/sec) connected to the above-mentioned multifunctional device;
- f) an information stand for the latest information for Mass Media including, but not limited to:
- a sign with the Wi-Fi network identifier (SSID) and password (A5 format, at least 10 signs);
 - a sign with phone numbers of press officers (or Club employees performing these functions) of both Clubs;

- g) lockers for temporary storage of photographers' equipment — at least five (5) lockers with minimum width of 575 mm and depth of 500 mm;

- j) 2 waste bins and 2 cloth hangers;
- k) Game report holders (the A4 size) – 2 pcs. (one holder is in the press-center, another one is

1.28. The following areas and premises shall be covered by the wireless Internet access network (Wi-Fi network supporting WPA2 Personal secure access technology):

a) guaranteed outgoing traffic speed of at least 50 Mbit/sec must be provided at the Press Center, at the Press Box, in the areas for accredited photographers at the grandstand and along the rink perimeter, as well as in the mixed zone, flash interview area, and in the room for press conferences throughout the entire period of operation; free use option shall be provided to accredited mass media representatives (mandatory SSID is KHL_Media);

b) guaranteed outgoing traffic speed of at least 20 Mbit/sec must be provided at the premises, boxes and in areas allocated to KHL, as well as in the room for the Official Game Report execution with the free use option for KHL employees at least 3 hours prior to and 2 hours after KHL Games or other events to be held at the Sports Facility jointly with KHL (mandatory SSID is KHL_OOF);

Access passwords for the above-mentioned networks shall be set by the Sports Facility specialists and provided to the KHL Information Technology Department no later than 10 business days prior to the season start and shall be changed during the season upon KHL request.

1.29. Press Box for Accredited Mass Media Representatives:

- a) located at the Sports Facility grandstand on the opposite side from the Players' Bench (not higher than the box level) to ensure full view of the rink and Players' Benches;
- b) there shall be at least 30 equipped workplaces and at least 50 during the Championship Stage Two;
- c) all workplaces shall be equipped with desks and extension cables for at least 2 electric sockets for one workplace;
- d) five (5) workplaces (15 workplaces during the Championship Stage Two) shall be equipped with a wired Internet connection (including no less than 2-meter-long Ethernet cable with the RJ-45 connector for each workplace).

1.30. Soundproof room for press conferences with the following equipment:

- a) seating for at least 30 Mass Media representatives;
- b) a presidium desk with a solid front panel, 4 soft chairs, desk name plates, tribune for the press officer of the host Club;
- c) audio equipment and a microphone for each presidium seat (or a conference system for at least 4 speakers);
- d) one (1) wireless microphone for questions from Mass Media representatives;
- e) glasses and still water bottles for speakers and Mass Media representatives. If KHL has a Championship sponsor/partner/advertiser of the "Drink" product category, water for the press conferences shall be provided to KHL by the sponsor/partner/advertiser;
- f) KHL advertising banner of at least 2x4 meter size.

If a Sports Facility construction and architecture make it impossible to hang the 2x4 meter advertising banner, the banner size shall be agreed with KHL.

1.31. Mixed zone for meetings of Accredited Mass Media Representatives with Hockey Players and team Coaches as close as possible to dressing rooms of participating teams. The mixed zone shall be spacious enough for all interested Mass Media representatives and easily accessible from media areas. If a Sports Facility construction and architecture make it impossible to organize a mixed zone at a location equally convenient for participating teams, an additional mixed zone may be organized to meet the above-mentioned requirements. The mixed zone shall be equipped with a TV set with display size of at least 40 inches for viewing direct Game broadcast (if it is prepared), as well as KHL advertising banner of at least 2x3 meter size. If a

- Sports Facility construction and architecture make it impossible to hang the 2x3 meter advertising banner, the banner size shall be agreed with KHL.
- 1.32. Flash interview area located close to the rink entrance for teams if the Sports Facility design makes it possible. The flash interview location shall be equipped with the KHL advertising banner of at least 2x3 meter size, while the upper edge of the banner must be located at a height no less than 2.5 meters above the floor, as well as three electric sockets (and a special “TV” sign). If a Sports Facility construction and architecture make it impossible to hang the 2x3 meter advertising banner, the banner size shall be agreed with KHL.
 - 1.33. Areas at the Sports Facility grandstands for at least ten (10) accredited photographers marked with the “PHOTO” sign; workplaces for accredited photographers along the rink perimeter, except for areas where spectators’ seats are located closely to the rink. Areas along the rink perimeter for at least ten (10) photographers must be marked with the “PHOTO” signs on boards from the stand side. In the areas near the rounded corners of the hockey rink, two (2) wired Internet connections must be available (a socket and at least 2-meter-long Ethernet cable with the RJ-45 connector for each connection), and the sockets must be installed separately (at different rounded corners).
 - 1.34. Sufficient sites for positioning TV cameras (at least twelve (12) sites) and mini-cameras (at least six (6) sites). The leading camera site shall be located on the opposite side from the Players’ Benches. One of the mini-camera sites shall be located between the Players’ Benches of both teams. In addition, positioning of two TV cameras above the guest and host goal nets must be provided for, as well as access of TV company employees to the technical floor for installing the cameras. TV camera sites where contact with spectators is probable must be isolated by mobile fence barriers with a belt or otherwise.

 - 1.35. Sports commentator sites (no less than two) located at the same level with cameras on the side where major cameras are located. Each commentator site must provide for two seats, electric sockets, lighting, phone with an option to make long-distance calls, Internet access (Wi-Fi), ISDN line for organizing the commentator channel.
 - 1.36. At least three suspensions for original sound microphones above the hockey rink (center + 2 zones) and one suspension for original sound microphones over the center of the central grandstand, as well as equipment to transmit audio broadcast via 1–2 commentator channels from commentator sites and all suspensions for original sound microphones.
 - 1.37. Sites for OB Vehicles and remote transmitting devices (antennas, transmitters, etc.) with an option to connect them to stable and redundant power supply systems. The capacity of the electric board at SPTVTS to connect OB Vehicle to the primary power supply system of the Sports Facility shall be no less than 50 kW. There shall be connectors for 125A and 63A connections (main and standby connections). TV transport entry must be organized if agreed with the Club beforehand (OB Vehicle, mobile radio station, mobile satellite station, mobile electric power station and auxiliary equipment). The TV transport shall be parked near SPTVTS.
 - 1.38. Connection of the following TV areas to the standby system of power supply of the Sports Facility:
 - 1) OB Vehicle;
 - 2) camera installation sites;
 - 3) sports commentator sites;
 - 4) mixed zone;
 - 5) TV studio;
 - 6) premises for press conferences and interviews.
 - 1.39. The TV studio location shall be agreed with KHL;
 - 1.40. The average level of horizontal illuminance of the ice hockey rink surface during competitions (the “Game” mode) without TV broadcasting Ehor.av. — no less than 750 lx, horizontal

- illuminance uniformity factor E_{min}/E_{av} . — no less than 0.7.

- 1.41. The average level of vertical illuminance at the height of 1.5 meters above the ice rink surface towards the leading TV camera during competitions with color TV broadcasting $E_{vert.av}$. — no less than 2500 lx; towards secondary TV cameras $E_{vert.av}$. — no less than 1800 lx (the illuminance compliance with the requirements of this paragraph must be ensured within 3 years, i.e. before the 2021/2022 season start).

- 1.42. The vertical illuminance uniformity factor towards the leading camera E_{min}/E_{av} . — no less than 0.8 and E_{min}/E_{max} . — no less than 0.65; the horizontal illuminance uniformity factor E_{min}/E_{av} . — no less than 0.8.
The vertical illuminance uniformity factor towards other TV cameras E_{min}/E_{av} . — no less than 0.6 and E_{min}/E_{max} . — no less than 0.4.

- 1.43. The average level of vertical illuminance of first eight rows of the grandstands towards the rink center during color TV broadcasting — no less than 40% of $E_{vert.av}$ of the ice rink towards the leading TV camera.

- 1.43.1 The light pulsation factor of light sources shall be no more than 1 %.

- 1.44. Modern light sources with color rendering index Ra of at least 80 and color temperature of at least 5600 K for lighting the ice rink surface.
- 1.45. Balanced Internet connection at SPTVTS and at OB Vehicle equipment location (RJ-45 sockets) for TV purposes with a guaranteed outgoing stream speed of at least 20 Mbit/sec and no less than 5 Mbit/sec for the standby channel. Traffic from the IP addresses that are used for operation via these channels shall not be filtered with firewalls or translated using the NAT mechanism. IP addresses must be available within Internet. Technical parameters of the Internet connection and the mobile number of the Club (Sports Facility) technical officer shall be stored in an envelope by the Sports Facility head's secretary.
- 1.46. Continuous lighting in the Game mode during 60 minutes 2 hours prior to the Game start to setup video signal of TV cameras to meet the requirements of the KHL partner with no change in the lighting mode during the pregame warm-up and Game intermissions; lighting in the Game mode for 20 minutes after the final buzzer. Should the hockey rink lighting be changed for the purpose of a pregame show or team roster presentation, the lighting shall be switched to the Game mode no later than six minutes before the Game start or other time interval additionally approved with the KHL by the Club.

- 1.47. Stationary or extended tunnels (or other protective structures, except for nets) through which Players and Officials enter the ice to prevent physical contact of Players, Officials, Coaches and team personnel with supporters, as well as hitting Players, Officials, Coaches and team personnel with items thrown from the grandstands.
- 1.48. Video surveillance system installed pursuant to the terms and procedures of the Law making it possible to efficiently and fully control and record the situation in the areas adjacent to the Sports Facility, security check areas and Sports Facility entrances, at internal premises of the Sports Facility, at grandstands and in the ice rink. The video surveillance system shall be capable to operate in a manual and preset mode, store recorded data, process the resulting

KHL TECHNICAL REGULATIONS

images, print out the images (stop-frame). The video cameras shall support high resolution making it possible to identify objects in the picture.

The video surveillance system shall support continuous recoding:

- a) of the “away” sector from the moment when supporters enter the “away” Club supporters’ sector before the Game to the moment when they leave the sector after the Game end. The recorded video shall be stored by the Club no less than one month after the respective Game and presented to KHL immediately upon request;
- b) of the fan sector from the moment when supporters enter the fan sector of the host Club supporters to the moment when host fans leave the sector after the Game end. The recorded video shall be stored by the Club no less than one month after the respective Game and presented to KHL immediately upon request;
- c) the entrance area of the Chief Referees and Linesmen dressing room from the moment when the Officials enter the dressing room before the Game to the moment when they leave the dressing room after the Game end. The recorded video shall be stored by the Club no less than one month after the respective Game and presented to KHL immediately upon request;
- d) the entrance area of the Ice Arena Video Goal Judge from the moment when the Ice Arena Video Goal Judge enters the room before the Game to the moment when the Judge leaves the room after the Game end. The recorded video shall be stored by the Club no less than one month after the respective Game and presented to KHL immediately upon request;
- e) all sectors of the arena’s grandstands. The recorded data shall be stored by the Club for at least one month. Images (stop frames with time and date stamps) of all arena’s grandstands on the 30th minute of the Game retrieved from the video surveillance system cameras shall be forwarded to KHL within 12 hours after the end of each Game. The procedure and methods for presenting the images shall be regulated by the KHL Security Department issued before each season start.

- 1.49. Working premises for the competition organizer and coordinating bodies (committees, commissions) established to ensure public order and security during competitions at their respective venues; the premises shall be connected to the video surveillance system.
- 1.50. Premises for employees of the federal security service and bodies of internal affairs. When allocating premises for the above-mentioned bodies, foreign Clubs shall be guided by their national legislation.
- 1.51. Stationary walk-through metal detectors shall be installed at all entries to the Sports Facility selected for the Championship Games.
 - 1.51.1. Turnstiles at the entrance and at the exit in accordance with the requirements of Chapter 5, Article 5 of the KHL Club Ticket Service Regulations (Appendix 4 to the KHL Marketing and Communications Regulations).

- 1.52. Access control system in accordance with the requirements of Chapter 5, Article 6 of the KHL Club Ticket Service Regulations (Appendix 4 to the KHL Marketing and Communications Regulations).

- 1.53. Emergency lighting at the Sports Facility in good working order.
- 1.54. Ice maker (or provide ice in a special temperature-resistant container) in the team dressing room area for medical purposes.
- 1.55. Navigation system (noticeable sign boards and signages) in two languages (national language of the country where the Sports Facility is located and English), including designations of all areas and premises that shall be used during the Championship Games, as well as passages to

them for spectators, Mass Media Representatives, Hockey Players, Coaches, Officials, medical personnel, and Sports Facility personnel.

In the lobby of each spectator entrance to the Sports Facility, seating plans with indicated sectors shall be available.

- 1.56. The STM System installed and connected to power supply and required communications.

2. During the Regular Championship and play-off games, KHL Clubs must ensure proper maintenance of boards and safety glass shields. There shall be no contamination due to puck hits, fractures, cracks, etc. on boards and shields. Boards and shields shall be cleaned and polished (puck and skate marks) before every Game.

3. During the Regular Championship and play-off games, KHL Clubs must provide a group of technical personnel having neat appearance and wearing uniform clothes. The technical personnel shall have a set of tools for ice rink maintenance, board and safety glass maintenance, repair and replacement.
4. During the Regular Championship and play-off games, KHL Clubs must provide a group of technical personnel on skates (Appendix 9 to the KHL Sports Regulations) to collect pucks on the ice after pregame warm-up and clean ice during advertisement breaks. The personnel shall wear uniform clothes, have neat appearance, and have containers (buckets) for pucks, cleaning tools (spades, containers for snow).
5. The host Club must maintain the Players' Benches area in proper order during the Game. Wet cleaning shall be performed before and after warm-ups and during intermissions between Game periods.
6. The host Club shall restrict access to team dressing room area to prevent the presence of unauthorized persons there from the moment Club teams enter the Sports Facility to the moment when they leave the Sports Facility territory after a Championship Game or training session. During the above-mentioned period of time, access to the dressing room area shall be granted only to Hockey Players and team representatives who take part in the Game, Officials (if the Officials' room is located in that area), KHL representative according to Appendix 4 to the KHL Technical Regulations and additional KHL requirements, Game Inspector, Game Commissioner, Doping Control Inspector who collects samples.
7. The host Club must make sure that no unauthorized persons have access to technical areas adjacent to ice rink board during the Game or pregame warm-up. Access to the above-mentioned areas shall be granted only to Hockey Players and team representatives who take part in the Game, Sports Facility employees who maintain the ice rink, press photographers in accordance with their accreditation for certain sites, mini TV cameraman within a fixed site, official KHL representatives (Commissioner, Inspector, President, Vice-Presidents, KHL department directors), disabled persons and employees ensuring public order and security during the Game. However, the above-mentioned persons, excluding photographers, mini TV cameraman and disabled persons, may not approach the board closer than 1 meter (if it is possible to ensure from the technical point of view). Team representatives shall not be allowed to the TV zone located between the Player's Benches fenced by the protective glass regardless of the presence of Mass Media representatives at the Game.

8. The host Club shall provide cloakrooms in the adjacent territory of the Sports Facility where spectators can leave their items that are prohibited to carry on to the Sports Facility.
9. The host Club shall maintain the lost and found department at the Sports Facility with the

respective navigation signages.

10. During the period of 45 minutes before the Game start and 15 minutes after its end, the host Club shall provide spectators with wireless Internet access (Wi-Fi); minimum access speed at peak load shall be no less than 256 Kbit/sec per 1 user without limiting the volume of transferred data.
11. The host Club must ensure that mobile communication networks are available at the Sports Facility and take measures to maintain and improve the quality of mobile phone and Internet communications to provide stable and uninterrupted service to spectators even if the Sports Facility is full.
12. The host Club must provide an option to pay using bank cards at all points of sale at the Sports Facility.

13. At least one ATM must be installed in the Sports Facility lobby so that spectators can access it.

The host Club must ensure that the KHL's contractor that provides communication services is able to provide means of communication to deliver direct broadcasts of KHL events and organize remote operation of the KHL and FHR officials' department. The ability to provide communication services means the following in these Regulations:
 - 1) granting access to the KHL contractor to organize communication services, including access to lay communication cables using technical premises and constructions of the Sports Facility that are designed for such laying of cables;
 - 2) allocating a site for the Contractor's equipment and means of communication.*(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)*

CHAPTER 2. SAFETY ARRANGEMENTS

Article 4. General safety provisions

1. Ensuring the safety of teams, Hockey Players, Coaches, Club executives and other officers, Officials, Commissioners, Inspectors, KHL official representatives, Mass Media Representatives, spectators, and other persons during the Championship Games or other Championship events is based on the existing regulatory and legal framework at the location of each Championship Game or another KHL event, local regulatory acts of KHL on ensuring safety when holding Games.
2. Security during a Championship Game or another Championship event shall be ensured by the host Club unless KHL has established a different security procedure for a certain KHL event.

Article 5. Responsibility for safety and security arrangements

1. The host Club is responsible for ensuring security and safety during a Championship Game or another Championship event unless KHL has established a different security procedure for a certain event.
2. In addition to ensuring safety and security when holding a Championship Game or another Championship event, the respective Clubs must take security measures throughout the entire period of staying at the location of the Game, including meeting and sending off the visiting team and its supporters, Officials' teams, Commissioners, Inspectors, and KHL officers.
3. When playing a "home" Game, the host Club must take all the necessary measures to ensure proper safety and security during the Game in accordance with the national legislation of the countries whose Clubs take part in the Championship and the requirements of the KHL Technical Regulations.
4. The activities of Club officers with respect to safety and security during the Championship Games or other Championship events are coordinated by the head of the KHL Security Department and performed in close cooperation with law-enforcement agencies.

5. Each Club must have a fulltime deputy head of security responsible for ensuring safety and security. The employee shall have the following major functional duties:
 - 5.1. Interaction with law-enforcement agencies and other government authorities with respect to ensuring security of the Championship Games;
 - 5.2. Establishment of coordinating bodies (committees, commissions) to ensure public order and security during competitions at their respective venues;
 - 5.3. Ensuring security when playing “home” Championship Games, including the security of Hockey Players, Coaches, Club representatives, Officials, Commissioners, Inspectors, KHL representatives, Mass Media representatives, spectators and other persons at the respective Game location;
 - 5.4. Organization of security measures throughout the entire period of stay at the location of the Championship Game, including meeting and sending off the visiting team and its supporters, Officials’ teams, Commissioners, Inspectors, and KHL officers;
 - 5.5. Organization of efficient interaction to ensure security during the Championship Games with the employees responsible for ensuring the security of other KHL Clubs;
 - 5.6. Organization of interaction with supporters with respect to ensuring security;
 - 5.7. Ensuring the compliance of the Club’s memorabilia and support accessories with the requirements of the KHL Technical Regulations and selecting locations for their placement at the Sports Facility when playing “home” Games;
 - 5.8. Organization of interaction and collaboration with the Sports Facility administration with respect to its technical infrastructure, “away” sector arrangement, development of ticket programs for the Championship Games, and other issues in order to improve safety and security during the Championship Games;
 - 5.9. Organization of and participation in the development of Club programs aimed at improving the security level and public order, spectators’ compliance with the Code of Conduct during the Championship Games;
 - 5.10. Organization of measures to ensure safe operation of the Club;
 - 5.11. Organizing and providing briefings to managers of private security agency, security services, control and administration services that perform security activities at Sports Facilities where the Championship Games are played so that the above-mentioned agencies can ensure high-quality performance of tasks relating to the security and safety of the Championship Games in compliance with the requirements of the KHL Technical Regulations.
6. The Club employee responsible for organizing the security must comply with qualification requirements and be evaluated by KHL. Qualification requirements and the evaluation regulations shall be developed by the Security Department. The evaluation dates and its regularity shall be determined by KHL. Based on the evaluation results, the employee receives a qualification certificate that confirms he can perform measures to ensure security during the Championship Games.
7. Any decision of the host Club or the visiting Club on applying additional security measures during a Championship Game must be agreed with KHL in advance.

Article 6. Organization of measures to ensure security during the Championship Games

1. On the day of the Championship Game, in order to ensure its security in compliance with the KHL Technical Regulations, the employee of the host Club who is responsible for the organization of measures to ensure security shall manage the agencies of the respective Sports Facility that are engaged in the process of ensuring security and order. The employee’s instructions must be performed by managers and employees of security agencies, control and administration agencies, volunteers, etc.
2. The Club employee who is responsible for ensuring the security shall organize efficient interaction with the upper-level law enforcement officials and officers engaged in the enforcement of law and order during the Championship Game.
3. The Club employee who is responsible for ensuring the security shall provide assistance to the

KHL TECHNICAL REGULATIONS

Commissioner or Inspector assigned by KHL to the Championship Game in performing his functions.

4. The host Club ensures:

- a) safe stay of the visiting Club at the Sports Facility where the Championship Game is played and its adjacent territory from the moment of the visiting Club arrival to the Sports Facility for training or participating in the Game on Game day or on the eve of the Game, as well as safety of the sports equipment and other property of the visiting Club at the Sports Facility and its adjacent territory;
- b) taking all the necessary measures to ensure security of the Chief Referees and Linesmen, including escort from the ice rink to the Officials' room to prevent any contact of unauthorized persons with the Chief Referees and Linesmen and ensure public order in the area close to the Officials' room before the Game start, during Game intermissions and after the Game end, as well as escorting reserve Officials from the Officials' room to the Officials' desk during the play-off game series;
(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)
- c) taking all the necessary measures to ensure security of the Ice Arena Video Goal Judge, including organizing the guard post at the entrance to the premises of the Ice Arena Video Goal Judge throughout the entire period of the Judge's stay at the Sports Facility. The guard post grants access to the premises only to the Ice Arena Video Goal Judge, Inspector, Game Commissioner, and the Club technician who maintains the Video Goal System;
- d) proper control of spectators' passage to the Sports Facility grandstands in accordance with duly executed official documents (tickets, season passes, accreditations, invitations, etc.) so that on the Game day no person who uses obviously falsified documents (mismatch of color, size, illustration, paper structure, text, etc.) can enter the Sports Facility. Presence of spectators at the grandstands in excess of the prescribed seat capacity of the Sports Facility (individual spectator seats) is strictly prohibited;
- e) proper control of spectators' passage to the Sports Facility with respect to ban on carrying items and substances inside the Sports Facility that are prohibited by the Code of Conduct at the Sports Facility (Appendix 6 to the KHL Technical Regulations);
- f) proper control of spectator's compliance with the Code of Conduct at the Sports Facility in order to prevent and suppress incidents and disorder, throwing items and substances to the grandstands and ice rink, to spectators, Hockey Players, Coaches, Officials, Club representatives, Sports Facility representatives, law enforcement officers, competition organizer's officials, and other negative behavior. The exception is throwing caps onto the ice by fans if during one Game of the Championship a player of the playing teams scores 3 (hat-trick) or more goals. Throwing caps onto the ice under these circumstances is adherence to the world hockey tradition and is not dangerous for participants of the Game;
- e.1) access control around the Sports Facility for holders of the KHL Certificates in compliance with the KHL Certificate Provision (Appendix 4 to the KHL Technical Regulations), for KHL accredited persons, for persons under the League's lists to access to separate areas of the Sports Facility, and other access control provided by the KHL;

- g) security during after-game press conferences and safety of its participants eliminating the possibility of visiting the press conference by people who have no duly executed accreditation;
 - g.1) security and control of access to the Press Box for the accredited mass media representatives;
(last updated on July 4, 2019. Minutes of meeting of CHL LLC Board of Directors No. 96 dated July 4, 2019)
 - g.2) security and control of access to the press-center for the accredited mass media representatives;

- h) security and control of access to mixed zones designed for meetings of Accredited Mass Media Representatives with Hockey Players and Coaches, as well as during meetings of Accredited Mass Media Representatives with Hockey Players and Coaches in team dressing rooms after the Championship Game;
- i) security and control of access to TV camera sites and sites for video recording by team employees;
- j) the required amount of technical equipment and specialists trained to quickly deactivate pyrotechnics, respond during an emergency (fire, smoke spread, etc.);
- k) security and control of access to the Doping Control Station, including organizing a guard post at the entrance to the Doping Control Station from the end of the second Game period to the moment when the last sportsman leaves the Doping Control Station. The guard post shall grant access to the above-mentioned premises only to authorized persons specified in Appendix 11 to the KHL Medical Regulations. The guard post is organized only if the doping control procedure is performed during the Game;

- l) take all the necessary measures to ensure the security of the Penalty Box and the Officials' team, as well as adjacent areas (technical zones and passages, stands) taking account of using video review procedures upon a Coach's request. Only the Officials' team, the Chief Referee, and Linesmen are allowed to access the Officials' box during the Game, including intermissions.

Article 7. High-risk Games

- 1. KHL may decide to assign a Championship Game to the high-risk category at its own discretion or upon a Club request if the Club has reason to expect that conflict situations may occur during the Game.
- 2. KHL shall send its Commissioners to the high-risk Games.
- 3. If a Championship Game is included in the high-risk category, the host Club shall take additional measures to ensure its safety and security and inform law-enforcement authorities about such a Game in a timely manner.
- 4. The Championship Game may be included in the high-risk category due to the following factors:
 - a) The Game is highly important from the sports point of view;
 - b) It is a Derby Game;
 - c) The Game is played between teams whose supporters are uncompromising opponents;
 - d) The number of "away" supporters that are expected to visit the Game is in excess of the number of tickets to be allocated to "away" supporters under these Regulations;
 - e) The Game has an international status;
 - f) There is information that certain circumstances may obstruct the normal course of the Game.
- 5. Should the Championship Game be included in the high-risk category, KHL is entitled to cancel organizing the "away" sector and revoke the right of the visiting Club to buy out Game entrance tickets for the Club's supporters. Entrance tickets for the specified sector shall be sold to the host Club supporters.

CHAPTER 3. SPECTATORS (SUPPORTERS)

Article 8. Responsibility

- 1. The Club shall organize interaction with its supporters and bear responsibility for their conduct

during the Championship Games.

2. A spectator (supporter) shall be held liable for a violation of the applicable law of the country where the Club's "home" Game is played, Code of Conduct at the Sports Facility (Appendix 6 to the KHL Technical Regulations).

3. The Club shall publish the text of the Code of Conduct at the Sports Facility on its official website. Foreign Clubs shall publish the Code of Conduct at the Sports Facility in Russian and in English, as well as in the national language of their country. The Code of Conduct shall be published on the official website separately from other documents on a page that can be easily accessed by the website visitors.

4. The Club must display the text of the Code of Conduct (extract from the Code) at the Sports Facility where "home" Games are played, in the ticket office area, at the Sports Facility entrances, at the entrances to grandstands sectors, as well as organize broadcasting of the text at the Sports Facility.

Article 9. Requirements to Clubs relating to interaction with spectators (supporters)

(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)

1. Each Club must have a fulltime employee responsible for the interaction with supporters, as well as an employee responsible for the interaction with spectators.

2. The Club shall organize interaction with spectators (supporters) in the following areas:

(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)

- 2.1. Development and implementation of various programs (season passes, tickets, marketing, etc.) aimed at attracting spectators to the Championship Games, ensuring comfortable and safe environment for them at the Sports Facility.

(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)

- 2.2. Interaction with supporter alliances aimed at organizing the Club team support during the Championship Games, including "away" Games, within the scope of these Regulations and Code of Contact at the Sports Facility.

- 2.3. Interaction with the Club supporters whose residence is outside the region of the Club base, their information support, including ticket programs for both "home" and "away" Games of the Club.

- 2.4. Organizing the Club supporters' trips to "away" Games of the Championship.

- 2.5. Participation of a Club employee in charge of supporter relations during "away" Games in order to ensure day-to-day interaction with the representatives of the host Club and law-enforcement authorities.

- 2.6. Sales of tickets to "away" Games to the Club supporters.

- 2.7. Ensuring comfortable and safe conditions for the visiting Club supporters at the Sports Facility: organizing the "away" sector, making it possible for visiting supporters to stay at the Sports Facility as part of a compact group, approval of the Club means of supporting in a timely manner, information support, etc.

- 2.8. Development of the spectators' (supporters') behavioral philosophy when visiting the

Championship Games and supporting their team.

- 2.9. Taking all possible measures to prevent access of those spectators (supporters) who violate the public order and Code of Conduct at the Sports Facility to the Club Games.

Article 10. “Away” sector (sector for active support)

1. The “away” sector is a section of the Sports Facility grandstand (several sectors, a sector, part of a sector) where visiting Club fans and, optionally, supporters are located in a compact manner and separately from other spectators.
2. The “away” sector must be confined by security areas all around. The security areas (passages, stairs, several rows of vacant seats) are created to prevent close contact between the visiting teams’ supporters and host teams’ supporters, as well as supporters trespassing. The security areas shall be controlled by officers of the agencies that ensure order and security during the Game.
(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)

3. The visiting Club is granted the right to buy out on a priority basis entrance tickets to the Championship Game for its supporters in the “away” sector in the amount of 3 % of the total number of spectator seats at the Sports Facility where the Game is played, as long as the request for buying out the above-mentioned entrance tickets is submitted no later than 48 hours before the Game start (24 hours for play-off series), and the tickets are purchased no later than 2 hours before the Game start.

No perfunctory approach is allowed when submitting the request by the visiting Club with respect to the number of entrance tickets for its supporters in the “away” sector (formal overstatement of the amount based on the 3 % quota; understatement of the amount; failure to submit the request). The visiting Club must have objective information on the number of its active supporters who intend to visit the “away” sector during the “away” Game of their team and reflect it in the request.

4. The “away” sector size shall comply with the requirements of the KHL Technical Regulations as to the number of tickets allocated to the visiting Club and security requirements. The host Club shall reserve additional seats in the “away” sector in the amount of 10 % of the number specified in the visiting Club request in case more unaccounted guest supporters arrive to the Game as long as the total number of tickets to the Game for guests does not exceed the number prescribed by the KHL Technical Regulations.
5. If the visiting Club fans appear in other sections of the stadium, the host Club must promptly take measures to move the fans to the “away” sector.
6. The host Club may reduce the “away” sector size based on the visiting Club request making sure the security requirements are met.
7. The host Club may increase the “away” sector size as compared to the size prescribed hereby based on commercial interests or agreements with the visiting Club making sure the security requirements are met.
8. If only a part of a Sports Facility sector is used as the “away” sector, it shall be located at the upper part of the grandstand, tier (no other spectators shall be seated behind the visiting team supporters).
9. The “away” and fan sectors must be located at the opposite grandstands.
10. Selling tickets to the host team supporters to the “away” sector is prohibited.
11. The host club must take measures to localize visiting team supporters throughout the territory of the Sports Facility: at canteens, smoking areas, public areas, stairs, passages. The measures may include changing the location of the “away” sector, adjustment of spectator flows within the Sports Facility area, changing the location of meal stations, entrances to the Sports Facility and so

on.

12. Any changes in location of the “away” sector or “supporters” sector shall be approved by the KHL Security Department.

Article 11. Memorabilia, means of supporting

1. During the Championship Games, spectators (supporters) may bring the following things to the Sports Facility and use them during the Game to support their Club:
(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)
 - a) scarfs, hats, clothes bearing the Club emblems;
 - b) memorabilia officially sold by Clubs.
2. The memorabilia owners must present it at the entrance to the Sports Facility.
3. Representatives of supporters’ alliances are allowed to use the following things as long as a responsible person is assigned to each of them:
 - a) drums with one membrane and open bottom, diameter of up to 60 cm and height of up to 40 cm, with standard drumsticks;
 - b) banners of various configurations provided that they are placed at the grandstands in the way that does not create inconveniences for other spectators watching the Game. Banners’ position in the Sports Facility shall be determined by a representative of the host Club who is responsible for the Club security organization in consultation with the Sports Facility administration, senior law enforcement officer of the security control center during the Game and firefighting service representative. The banners shall be made of non-flammable materials (treated with special compounds) and have the appropriate fire safety certificates. The content of the banners shall be aimed only at supporting the Club and shall not contain offensive, obscene, provocative, defamatory texts, words, symbols, images;
(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)
 - c) flags attached to a hollow plastic staff. The length of the staff cannot exceed 1.5 m. The flags shall be made of non-flammable materials (treated with special compounds) and have the appropriate fire safety certificates. The use of such flags is allowed in the “home” and “away” sectors. Images on the flags shall be aimed only at supporting the Club and shall not contain offensive, obscene, provocative, defamatory texts, words, symbols, images;
(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)
 - d) means of supporting containing words and expressions in the official languages of republics of the Russian Federation or official languages of the countries whose Clubs participate in the Championship shall have a translation certified by the Club;
 - e) means of supporting containing words and phrases in languages that are not specified in the previous item d must be notarized;
 - f) means of supporting containing abbreviations and combinations of digits shall have a written explanation of the meaning of such abbreviations and combinations of digits certified by the Club;
 - g) other means of Club supporting. The use of other means of supporting may be allowed by the joint decision of the organizer, Sports Facility administration and the senior law enforcement officer of the security control center of the Championship Game as long as the means of supporting meet security requirements and do not disturb spectators.
4. The number of drums, other means and methods of Club supporting, including team mascots, that are used by the visiting Club supporters, shall be determined by the host Club in advance and agreed with the Sports Facility administration, law enforcement agency center, firefighting service.

KHL TECHNICAL REGULATIONS

In case of disagreement with the methods and the amount of means of supporting specified in the entrance ticket purchase request, the host Club shall inform the visiting Club respectively no later than 24 hours before the Game start (during play-off series — in a timely manner). No response to the request from the host Club means its approval to use the declared means and methods of supporting.

5. The owners of the above-mentioned means of Club supporting shall present them 1.5 hours before the Game to representatives of the host Club, Sports Facility administration, security control center and firefighting service for checking them for compliance with the requirements.

In the event of non-compliance with the requirements of this Article of the KHL Technical Regulations, as well as Code of Conduct by the Club supporters, any of the above-mentioned means of Club supporting may be banned.

6. Means of Club supporting during “home” Games (show programs, theme music, etc.) shall not:
 - a) be offensive, slighting, or discrediting with respect to the visiting Club and its supporters, and provoking their negative response and consequences;
(last updated on July 4, 2018. Minutes of meeting of CHL LLC Board of Directors No. 85 dated July 4, 2018)
 - b) use Nazi emblems, words or expressions, attributes and symbolics and extremist paraphernalia, as well as using emblems and symbols confusingly similar to them.
7. When preparing and performing a show, Clubs are prohibited to use pyrotechnical products, open fire, including cold and arc lamp projectors, fireworks, and other types of fire effects in the Sports Facility before, during, and after the Championship Games. When ensuring safety and security, foreign Clubs shall apply this provision in accordance with their national legislation.
8. When preparing and performing a show, the host Club must ensure that officers and professionals (team mascot, show presenters, and other professionals who deal with spectators during the Game) do not commit any actions that incite supporters to violate the Code of Conduct at the Sports Facility or supporters’ aggression or unrest at the Sports Facilities.

Article 12. Ticket program

1. The Club shall maintain an electronic ticket system complying with the requirements of the KHL Club Ticket Service Regulations (Appendix 4 to the KHL Marketing and Communications Regulations).

- 1.1. The Club shall provide KHL with information on the number of sold tickets at grandstands (sectors) of the Sports Facility automatically in the real-time mode in accordance with Chapter 7, Article 2 of the KHL Club Ticket Service Regulations (Appendix 4 to the KHL Marketing and Communications Regulations).
(last updated on August 7, 2020. Minutes of meeting of CHL LLC Board of Directors No. 109 dated August 7, 2020)
2. When manufacturing entrance tickets, season passes, the host Club shall provide for several levels of protection to complicate their counterfeiting.
3. The entrance ticket, season pass shall contain the required information for its owner: Game name, Sports Facility name, date and time of the Game start, specify the grandstand, sector, row and seat, as well as entrance (optional), extracts from the Code of Conduct at the Facility relating to spectator’s duties and items that are banned from bringing to and using at the Sports Facility, of a link to the above Code of Conduct, as well as other information mandatory for specifying as per the requirements of the legislation in the country of the Game.

4. At the ticket offices of the Sports Facility where the Championship Game is played, all the required information for spectators (supporters), including the supporters of the visiting Club, shall be available: specification of the “away” sector, availability of a certain Game entrance tickets for sale (at ticket offices or via the visiting Club). A separate ticket office must be assigned for the visiting Club supporters.
5. In the ticket office area must be placed Code of Conduct at the Sports Facility (extracts from the Code). Foreign Clubs shall place the Code of Conduct at the Sports Facility in Russian and in the national language of their country.
6. For supporters who live in others cities and countries KHL Clubs introduce the system of selling entrance tickets to “away” Games through the Club (through Club representative working at the “away” Game), taking into consideration that the visiting Club must be aware of the number of supporters planning to visit the “away| Game of the Club to submit objective data in the request for entrance ticket purchase.
7. Clubs develop the ticket and season pass program for the Championship Games taking account of the requirements for organizing the “away” sector.
8. Selling and distributing tickets to the “away” sector online is prohibited.
9. During the Game the host Club must ensure the security of Players, team representatives and Officials on the ice, in the Players’ Bench and Penalty Box areas to prevent their physical contact with spectators. For these purposes, the host Club shall take all the required measures, including reserving the required number of seats close to Players’ Benches and Penalty Boxes, as well as in the areas where spectators may enter the ice rink. These seats are allocated to representatives of the structures ensuring public order and security.
10. The host Club interacts with the law enforcement bodies, develops and implements measures to prevent selling tickets to the Championship Games by institutions and persons that are not officially contracted by the Club to sell the tickets. The Club may restrict the number of tickets sold to one person.
11. The host Club must provide the visiting Club entrance tickets to the Championship Game in accordance with Chapter 2, Article 4, clause 4.11 of the KHL Club Ticket Service Regulations (Appendix 4 to the KHL Marketing and Communications Regulations).

12. The host Club must provide KHL or persons specified by KHL free entrance tickets in accordance with Chapter 2, Article 4, clause 4.3.1-4.3.2 of the KHL Club Ticket Service Regulations (Appendix 4 to the KHL Marketing and Communications Regulations).
(last updated on August 7, 2020. Minutes of meeting of CHL LLC Board of Directors No. 109 dated August 7, 2020)
13. The host Club must ensure priority right to purchase the tickets by KHL or persons specified by KHL in accordance with Chapter 2, Article 4, clause 4.3 subclause 4.3.3 of the KHL Club Ticket Service Regulations (Appendix 4 to the KHL Marketing and Communications Regulations).
(last updated on August 7, 2020. Minutes of meeting of CHL LLC Board of Directors No. 109 dated August 7, 2020)
14. Price of tickets to the “away” sector shall not be higher than the price of tickets to adjacent or similar sectors of the arena.

CHAPTER 4. FINAL PROVISIONS

The KHL Technical Regulations come into effect from the moment they are approved by the CHL LLC Board of Directors and shall remain effective until the approval of the new KHL Technical Regulations.

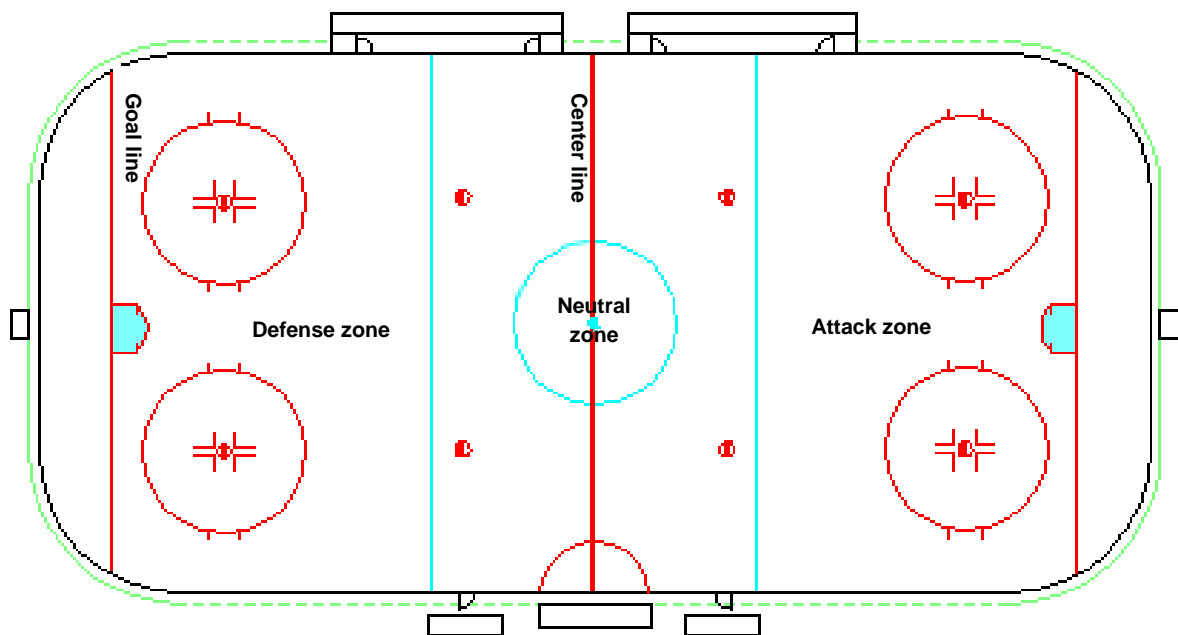

KHL Certificate PROVISION

KHL Certificates are issued to KHL representatives, KHL Club representatives, Officials and Agents for the performance of their official and other duties during the Championship Games and training sessions at the Sports Facilities where KHL Championship Games are held.

The KHL Certificate does not grant the right to take seats at the grandstands to which tickets and season passes are sold. As an exception, the host Club may decide to let KHL Certificate owners take spectator seats if the arena’s grandstands are not full.

All KHL Certificates are issued after registration by KHL and must be returned to KHL during the dismissal according to established procedure.

The effective term is specified in the KHL Certificate.

KHL may specify or supplement details of access to certain areas and premises of the Sports Facility by means of separate orders before the season start and during the season.

KHL Certificates are divided in the following categories

1. Certificates of KHL representatives and KHL Officials (2 types: VIP and Standard)

VIP KHL Certificate (for KHL representatives)



Issued to KHL top managers and to heads of KHL departments.

VIP KHL Certificate issued to a KHL employee grants access to all areas of the Sports Facility, except for the Officials’ room, room of Ice Arena Video Goal Judge, team dressing room areas, Doping Control Station, and government boxes during any Championship Game.

Note. Owners of VIP KHL Certificates — KHL Chief Referee and members of Officiating Department — are also entitled to enter the Officials’ room and the room of Ice Arena Video Goal Judge.

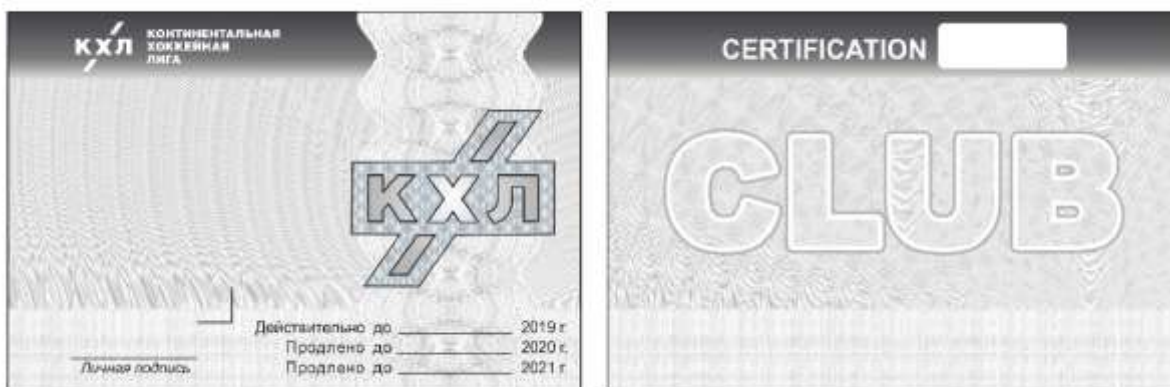

grants access to all areas of the Sports Facility, including the team dressing room areas, dressing room of their own Club, except for the Officials' room, room of Ice Arena Video Goal Judge, dressing room of the rival team, Doping Control Station, and government boxes;
- **during a Championship Game in which the Club team does not takes part:**
grants access to the Sports Facility.

VIDEO GOAL SYSTEM REQUIREMENTS

1. The Video Goal System shall consist of one or more servers that can receive at least sixteen (16) input channels of video images from a set of fifteen (15) video cameras installed in the Sports Facility, and a television broadcast signal with the ability to transmit these video data from one output channel in one video stream to the Video Review Room in the FHR office. The use of additional video streams for transmitting video data from the Video Goal System to the Video Review Room in the FHR office is not allowed.

1.1. The set of video cameras includes:

- a) three cameras for each of two goal nets (one camera above the goal net, one camera in the goal net, one camera behind the goal net);
- b) two cameras on both sides of each blue line;
- c) two corner cameras at each half of the ice rink;
- d) the signal of the Game TV broadcast, and in case of its absence, the video signal from the arena's cameras intended for the video board (video cube);
- e) one panoramic camera covering the entire ice rink;
- f) images from all cameras of the Video Goal System shall be synchronized according to the recording time (timecode). When switching the cameras, the Video Goal System shall display the same frame from all available cameras, synchronized by a timecode.

1.2. The Video Goal System shall be equipped with the following:

- a) an internal hard disk, simultaneous recording functions (starting from 60:00 minutes before the start of the Game and until the teams leave the rink at the end of the Game) and playback of signals from all cameras installed in the Video Goal System and the television signal. In the absence of a television broadcast – a video signal from the arena cameras intended for the video board (video cube);
- b) two monitors for the TV signal and signal of the Video Goal System with a size of at least 22 inches and a resolution of at least Full HD 1080p;1920×1080;16:9 in the Video Replay Judge's room;
- c) a monitor with a size of at least 22 inches and a resolution of at least Full HD 1080p;1920×1080;16:9, installed on the table of the Officials team for viewing controversial moments, synchronized with the equipment in the Ice Arena Video Replay Judge;
- d) three-way telephone communication (triplex) with a headset (headphones and microphone) for negotiations between the Chief Official and the Ice Arena Video Replay Judge and the KHL Video Review Specialist;
- e) a three-way communication channel with a headset (headphones and microphone) for negotiations between the Chief Official and the Ice Arena Video Replay Judge and the KHL Video Review Specialist;
- f) the technical ability to display the Game time (timecode) on the monitor of the Ice Arena Video Replay Judge when viewing controversial moments obtained from the cameras of the Video Goal System;
- g) control button for the orange lamp installed at the Official's table;

h) a manual stopwatch.

2. Equipment of the Video Goal System shall comply with the following requirements:

a) receiving video information from two hockey goals using color video cameras for a full view of the goal area with cameras in the goal net, behind the goal net and above the goal net. Video cameras and servers shall have the following video output parameters: a resolution of at least Full High Definition 1920×1080p or 1920×1080i, with a frame rate of at least 50 frames per second. The camera in the goal net shall be installed on the rear vertical post of the goal in its upper part. The lens shall be positioned at the junction of the upper inner arc and the central goalpost and point down at the goal line. The camera's view shall cover the entire goal line and the lower parts of the bars and the goal area. The goal line in the picture shall be straight. The camera behind the goal shall be installed strictly in the center from the outside of the board. The lens shall be positioned so that the crossbar of the nearest goal coincides with the crossbar of the far goal. The camera's view shall include the goal and a section of the ice rink at a distance of one or two meters relative to the goal. The chamber over the goal shall be set in such a way that the camera covers the goal, the goal zone, the part of the rink at a distance of two meters outside the goal, two meters from the side of the goal and part of the ice rink near the hash mark of the faceoff circles in front of the goal. The goal line in the image from the camera above the goal shall be straight and completely overlap the plane of the goal line. The location of cameras behind the goal, above the goal, and in the goal, as well as images from cameras in the goal, behind the goal, and above the goal, must correspond to the images and diagrams specified in Appendix 5 to the KHL Technical Regulations. The location of the above cameras must be approved by the KHL Officiating Department at least two weeks prior to the team's first home Game at the Sports Facility.

b) receiving video information from Full High Definition 1920×1080p or 1920×1080i video cameras, with a frame rate of at least 50 frames per second on blue lines (2 cameras on both sides on each blue line), which shall be able to increase the digital zoom 4-6 times. The optical capabilities of the cameras shall provide a high-quality and clear image to the server. The signal from the cameras shall be sent to the Official's team desk, the monitor of the Ice Arena Video Replay Judge, and the Video Review Room in the FHR office. These video cameras shall be installed at a minimum distance of 1 meter up above the protective glass so that the entire blue line and continuations of the line on the boards are covered by the camera view, and no structures of the Sports Facility, and none of the Players, team representatives, Officials, spectators could not block or otherwise interfere with the view for the purposes of reviewing the controversial moment. The location of the cameras on the blue lines shall be approved by the KHL Officiating Department at least two weeks before the team's first home Game at the Sports Facility.

c) receiving video information from four (4) Full High Definition 1920×1080p or 1920×1080i video cameras, with a frame rate of at least 50 frames per second, capable of 4-6-fold digital zoom, installed in such a way that the entire surface of the ice rink with protective nets over the boards and Players' and Officials' Benches falls into the view of each of the four cameras (two cameras for each half of the ice rink). Clubs, in agreement with the Competition Department, may use other technical systems (TV stations, etc.) or cameras with magnification to provide an overview of the surface of the ice rink protective nets over the boards and Players' and Officials' Benches. The signal from additional cameras shall be sent to the Officials team desk, the monitor of the Ice Arena Video Replay Judge, and the Video Review Room in the FHR office. The location of the four additional cameras shall be approved by the KHL Officiating Department at least two weeks before the team's first home Game at the Sports Facility;

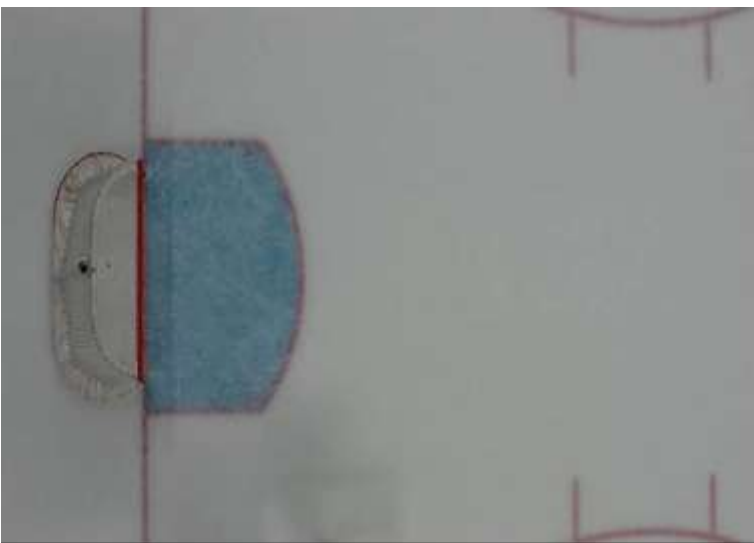
d) receiving the signal of the TV broadcast of the Game, and in its absence, a video signal from the arena camera intended for the video board (video cube) necessary for viewing and making a decision on the goal. Recording and playback of a television signal or video signal from cameras in the arena shall mandatorily be submitted to the Video Goal System;

- e) sending a signal from video cameras to the Officials team desk, the monitor of the Ice Arena Video Replay Judge, and the Video Review Room in the FHR office. The signal from the Video Goal System shall not be sent to the monitors of the Clubs that are installed in offices, service rooms, teams' dressing rooms or Players' Benches;
- f) recording of video information from cameras to the computer's hard disk shall be performed with a timecode from the timekeeping system;
- g) separate backup and transfer of the controversial moments related to the goal or imposing Major plus Game Misconduct and Game Misconduct penalties from cameras of the Video Goal System viewed during the Game by the Ice Arena Video Replay Judge at the request of the Chief Official or a the KHL Video Review Specialist which shall be sent via the Internet to a separate folder on the KHL technical server ftp://ftp.khl.ru in H.264 compressed format directly at the end of each home Game;
- h) the ability to view the video at random and prompt positioning of the desired fragments (controversial moments of goal scoring) for the Ice Arena Video Replay Judge of the Game and the KHL Video Review Specialist in the FHR office with the help of a specialist of the host Club;
- i) uninterrupted power supply for the duration of each Game;
- j) reliable operation in triplex mode, when simultaneously recording, viewing channels in real time and playback of recordings from the archive;
- l) the image of the Video Goal System in the Sports Facility shall be delivered to the Video Review Room in the FHR office for real-time display;

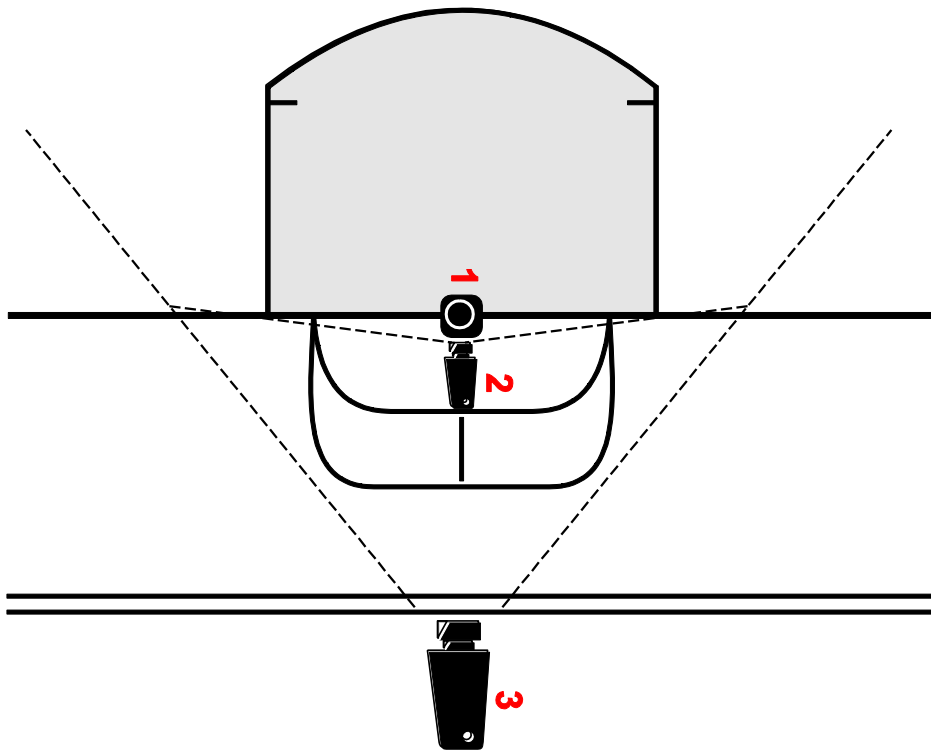

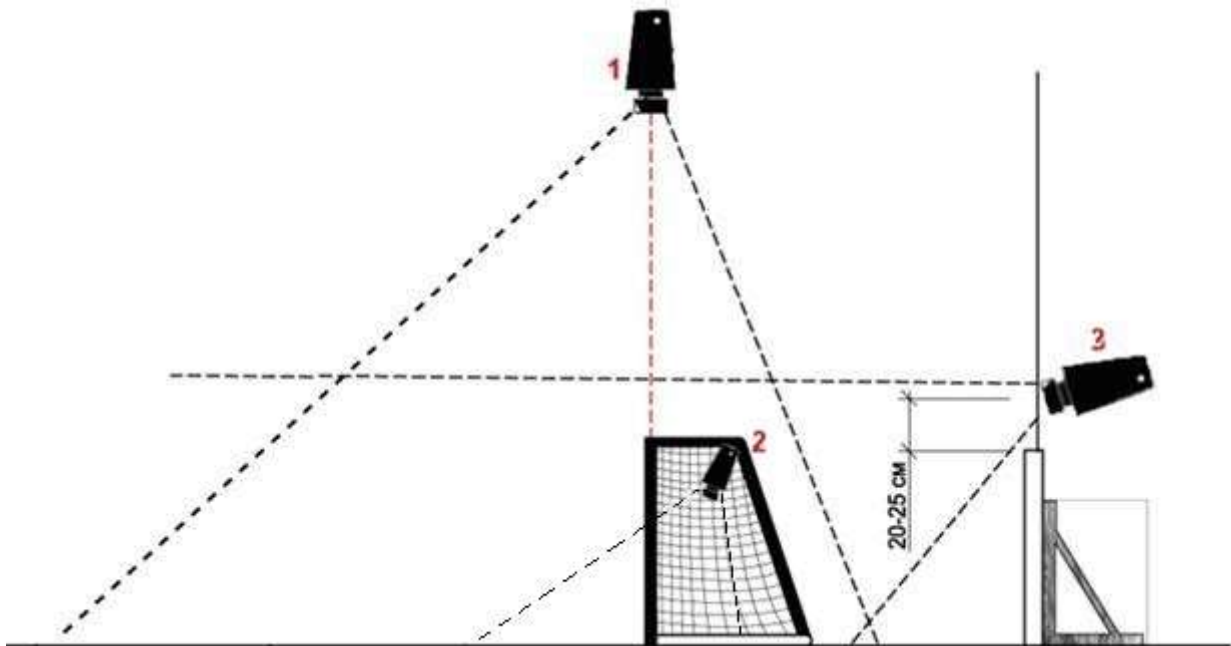


3.1. Locations of cameras above the goal net and behind the goal net (top view)

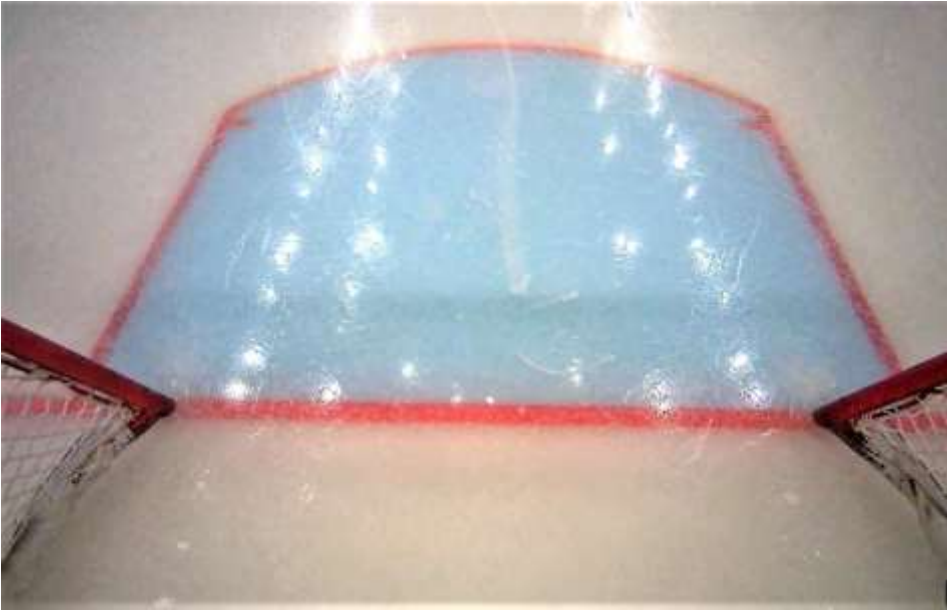
3.2 Locations of cameras above the goal net and behind the goal net (side view)



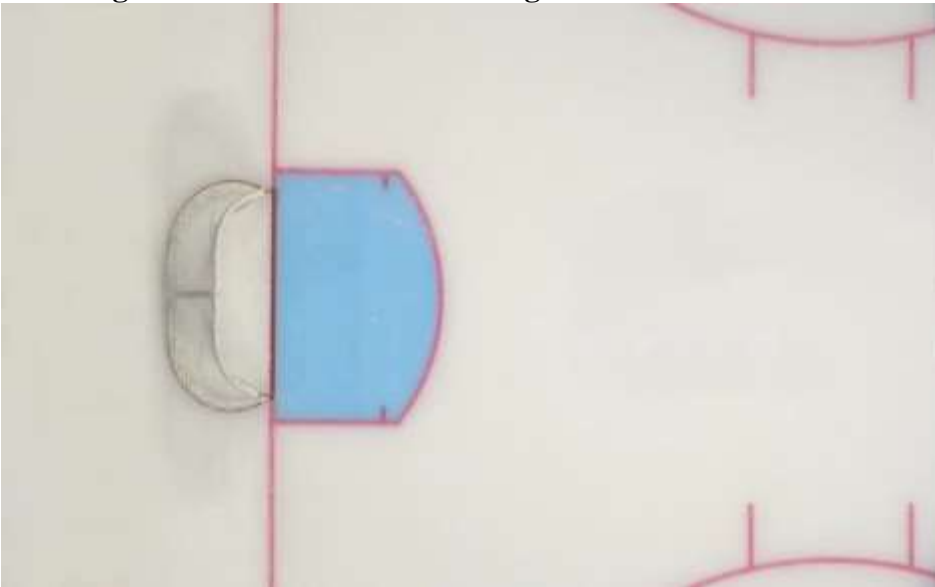

CODE OF CONDUCT FOR SPECTATORS IN SPORTS FACILITIES
(for KHL and JHL hockey Games)

This Code of Conduct determines the standards of conduct of spectators in the Sports Facility when attending ice hockey Games held in the Russian Federation and in foreign countries where a “home” Game of a foreign Club is played.

1. General provisions:

- 1.1. The spectators are the persons who enter the Sports Facility, have an entrance ticket, season pass, invitation or other documents of a standard form and are not involved in organization of the Game and any arrangements for holding the Game;
- 1.2. In order to ensure the safety of certain categories of spectators the organizer of the Game may introduce special Game attendance conditions for such categories subject to mandatory notification of the decision to the Sports Facility administration, law enforcement agencies and spectators prior to commencement of ticket sales;
- 1.3. By entering the Sports Facility, the spectators accept and voluntarily fulfill requirements of the Code of Conduct in force during their entire visit to the Sports Facility;
- 1.4. Compliance with the Code of Conduct shall be monitored by the organizers of the Game, co-organizers of the Game, law enforcement officers and fire safety inspectors as well as Sports Facility personnel engaged in entrance control, seating spectators and public order maintenance (Sports Facility security personnel, private security companies, stewards, administrators, volunteers, etc.);
- 1.5. The spectators that do not comply with the Code of Conduct as well as the persons subject to the court order that took legal effect in accordance with the legislation and prohibits such persons from visiting competition venues on the days of holding competitions shall be refused entry to the Sports Facility or shall be removed from the venue without ticket price refund and if they commit unlawful acts they shall be held administratively or criminally liable;
- 1.6. Organizers and co-organizers of the Game shall have the right to take photos or videos of spectators for the purpose of unlawful activities prevention;
- 1.7. A breach of the Code of Conduct by a spectator shall serve as the grounds for the organizers of the Game, co-organizers of the Game and Sports Facility administration to consider refusing the breacher the entry to the Sports Facility at the time of holding other Games.

2. Spectators have the right to:

- 2.1. Enter the Sports Facility before and during the Game if they have the tickets, season passes, invitations or other documents of a standard form. The time when admittance to the Sports Facility starts shall be determined by the joint decision of the organizer of the Game, Sports Facility administration and law enforcement agencies. The number of times a spectator may enter the Sports Facility during one Game having the ticket, season pass or other documents shall be determined by the Sports Facility administration;
- 2.2. Enjoy all the services provided by organizers of the Game, co-organizers of the Game and administration of the Sports Facility;
- 2.3. Bring to their seats in the Sports Facility and use:
 - tobacco products and lighters provided that they are used in the zones specially designated for smoking only;
 - memorabilia officially sold by Clubs in Sports Facilities;
- 2.4. Representatives of fan associations shall be allowed, for the purpose of supporting the team in the “fan” and “away” sectors and subject to designating the fans responsible for each item of means of supporting specified below, to bring and use:
 - drums with one membrane and open bottom, diameter of up to 60 cm and height of up to

40 cm, with standard drumsticks;

- banners of various configurations provided that they are placed at the grandstands in the way that does not create inconveniences for other spectators watching the Game. Banners' position in the Sports Facility shall be determined by a representative of the Club organizing the Game who is responsible for the safety in consultation with the Sports Facility administration, senior law enforcement officer of the security control center at the Game and EMERCOM representative. The banners shall be made of non-flammable materials (treated with special compounds) and have the appropriate fire safety certificates. The content of the banners shall be aimed only at supporting the Club and shall not contain offensive, obscene, provocative, defamatory texts, words, symbols, images;

- flags attached to a hollow plastic staff. The length of the staff cannot exceed 1.5 m. The flags shall be made of non-flammable materials (treated with special compounds) and have the appropriate fire safety certificates. The use of such flags is allowed in the "fan" and "away" sectors. The content of images on the flags shall be aimed only at supporting the Club and shall not contain offensive, obscene, provocative, defamatory texts, words, symbols, images;

- other means of team supporting. The use of other means of supporting may be allowed by the joint decision of the organizers, Sports Facility administration and the senior law enforcement officer of the security control center.

The means of supporting containing words and expressions in the official languages of republics of the Russian Federation or official languages of the countries whose Clubs participate in the Championship shall have a translation certified by the Club.

The means of supporting containing words and phrases in a foreign language must have a notarized translation.

The means of supporting containing abbreviations and combinations of digits shall have a written explanation of the meaning of such abbreviations and combinations of digits certified by the Club.

The owners of the above-mentioned means of supporting shall show them 1.5 hours before the Game to representatives of the organizer of the Game, co-organizer of the Game, Sports Facility administration, security control center and EMERCOM who check them for compliance with the requirements.

In the case of violation by the fans of the Code of Conduct, it may be decided to ban the use of the above-mentioned accessories at Games.

- 2.5. Take photos or videos without accreditation using cameras with the lens length not exceeding 20 cm and without any additional equipment, such as tripods, etc. (if their use is not banned by the organizer of the Game, it should be written on the ticket, season pass or invitation).

3. The spectators must

- 3.1. Show to entrance control personnel the tickets, season passes, invitations and other documents giving the right to enter the Sports Facility as well as the permits for cars to drive to the surrounding area.
- 3.2. Undergo screening (body search) and display personal belongings for inspection when entering the Sports Facility and in some cases when entering the surrounding fenced area in order to ensure security and prevent smuggling in prohibited items.
- 3.3. Take their seats in accordance with the tickets, season passes and invitations.
- 3.4. Fulfill lawful instructions of the organizer of the Game, co-organizer of the Game, Sports

KHL TECHNICAL REGULATIONS

Facility administration, law enforcement officers and fire safety inspectors, observe public order and generally accepted standards of conduct.

- 3.5. Immediately inform the Sports Facility administration and law enforcement officers about any suspicious items, smoke or fire, law infringements being committed, other security threats.
- 3.6. Treat property of the Sports Facility with care, respect cleanliness.
- 3.7. In the case of injury of a person or damage to property of a person as well as damage to property of a legal entity, including the organizer and co-organizer of the “home” Game, indemnify for such injury or damage in full in accordance with the procedure specified by the legislation not excepting satisfaction by him/her (the spectator) of the counterclaim (recourse) of the person that initially indemnified for the injury/damage.
- 3.8. Observe the generally accepted standards of conduct and show respect to the national symbols when before the Game of the Championship there is played the State Anthem of the Russian Federation, anthems of republics of the Russian Federation, anthems of foreign states.

4. The spectators are prohibited from

- 4.1. Being in the Sports Facility under the influence of alcohol, drugs or other intoxicants.
- 4.2. **Bringing** to the Sports Facility and **using**:
 - alcoholic drinks;
 - any kind of weapons and ammunition;
 - piercing and cutting objects;
 - smoke bombs;
 - flares;
 - signal rockets;
 - firecrackers;
 - pyrotechnic products;
 - other substances, items, products including homemade, the use of which may lead to smoke generation, fire and other adverse effects;
 - devices and products, including homemade, not being pyrotechnic products, used for scattering or dispersing different materials and substances (compressed air poppers, etc.);
 - flammable, explosive, toxic and poisonous substances as well as pungent smelling substances;
 - flammable, fire hazardous materials and objects;
 - colorants;
 - narcotic drugs;
 - radioactive materials;
 - nerve and tear gas canisters;
 - laser devices;
 - other objects that can be used as weapons;
 - cans, glass and plastic food containers, bottles;
 - bulky items (any objects whose dimensions in length, width and height exceed $40 \times 40 \times 20$ cm);
 - items the dimensions of which in length, width and height do not exceed $40 \times 40 \times 20$ cm but, in the Game co-organizer’s opinion, may create a hazard to safety of the Game participants or spectators or may become a bar to a normal holding of the Game;

 - sound amplification equipment;
 - pipes, whistles of any size, made of any material;
 - rattles made of any material;
 - radio sets;
 - promotional materials of an extremist nature or containing Nazi and/or extremist paraphernalia or symbols;

- 4.3. Smoking using electronic cigarettes and other devices simulating the process of tobacco smoking in the places where it is forbidden by the Sports Facility administration.
- 4.4. Starting fire.
- 4.5. Throwing objects (substances) onto the grandstands, ice and area around it and intentionally throwing objects at spectators, Players, Coaches, Officials, representatives of Clubs, Sports Facility, law enforcement officers, competition organizer's officials, or using objects (substances) the use of which may, intentionally or unintentionally, result in the landing of such objects (substances) or parts thereof in the above places or onto the above persons. The exception is throwing caps onto the ice by fans if during one Game of the Championship a player of the playing teams scores 3 (hat-trick) or more goals. Throwing caps onto the ice under these circumstances is adherence to the world hockey tradition and is not dangerous for participants of the Game.

- 4.6. Wearing and flaunting as well as using emblems, symbolics and other Nazi and extremist paraphernalia as well as using emblems and symbolics confusingly similar to them; publicly displaying any extremist paraphernalia.
- 4.7. Using words and expressions as well as gestures of fascist and racist nature.
- 4.8. Using obscene, offensive, defamatory words and expressions as well as gestures.

- 4.9. Using symbolics, banners, chants, shouts or gestures that incite social, racial, religious, national and interstate hatred as well as social, racial, religious, national and interstate superiority.
- 4.10. Insulting other persons in particular using means of supporting and paraphernalia and committing other actions discrediting the honor, dignity and business reputation of a person or a group of persons or a legal entity.
- 4.11. Using items of clothes and other objects and methods to hide the face.
- 4.12. Violating public morals and norms of behavior by baring body parts while in the Sports Facility.
- 4.13. Behaving in a provocative or threatening way in respect of spectators and participants of the Game, creating threats to their life and safety or life and safety of other people or endangering anyone in any way whatsoever.
- 4.14. Going beyond the fences to the ice rink and onto the ice rink, to dressing rooms of the teams and Officials, to Press Centers and other auxiliary premises.
 - 4.14.1. Entering the areas adjacent to the Sports Facility access to which is restricted by the organizer of the Game or the owner of the Sports Facility, as well as entering the Sports Facility zones not indicated in the ticket or in the document that substitutes it access to which is restricted by the organizer of the Game or the owner of the Sports Facility (ice rink and technical zones around the boards, media zone, zone for distinguished guests, technical premises, etc.).

- 4.15. Being in the aisles or on the stairs during the Game, interfering with the movement of participants and spectators, standing on chairs, jumping, simulating illegal actions, climbing on fences, parapets, lighting equipment, masts, supporting structures, damaging the property of the Sports Facility and spectators.
- 4.16. Bringing animals to the Sports Facility.
- 4.17. Committing any political acts and promotion actions.

- 4.18. Taking any public actions not approved by the organizer of the Game.
- 4.19. Selling or otherwise distributing advertising materials, souvenirs, materials of political, religious and racist nature (including posters, leaflets, brochures).

4.20. Illegally selling tickets to the Game.

DESIGNED SPORTS FACILITIES

1. In addition to the above-mentioned requirements of the KHL Technical Regulations, the design of a new Sports Facility for holding the Championship Games must provide for the following:
 - 1.1. Number of individual seats — no less than 12,000 in cities with a population of more than 500,000 people. In cities with a population of up to 500,000 people, no less than 9,000 individual spectator seats. In cities where two or more Clubs participating in the KHL Championship are based, no less than 9,000 individual spectator seats.
 - 1.2. 60 × 28 m hockey rink with a technical option to transform its size (56 × 28 m and 56 × 26 m and 60 × 26 m).
(last updated on February 27, 2020. Minutes of meeting of CHL LLC Board of Directors No. 104 dated February 27, 2020)
 - 1.3. Board system compliant with the requirements specified in Appendix 9 to the KHL Technical Regulations.
 - 1.4. At least four dressing rooms with an area of 100 m² each without taking account of premises adjacent to the dressing rooms (at least six shower cabins, no less than three toilet cabins, massage rooms, etc.).
 - 1.5. Premises equipped with washing machines for sports uniform washing.
 - 1.6. Separate entrances to the Sports Facility for the host team and the visiting team located near their dressing rooms and at a considerable distance from the entrance and the room for the Chief Referees and Linesmen.
 - 1.7. Separate entrance to the Sports Facility for the Chief Referees and Linesmen located close to the room of Chief Referees and Linesmen and at a considerable distance from teams' entrances and dressing rooms.
 - 1.8. Separate areas for dressing rooms and premises of the host team and visiting team adjacent to the dressing rooms.
 - 1.9. Separate area for the Chief Referees and Linesmen room.
 - 1.10. Two gym halls for quick warm-up of the host team and the visiting team.
 - 1.11. Separate premises for the quick warm-up of the Chief Referees and Linesmen located close to the room of the Chief Referees and Linesmen.
 - 1.12. Separate entrances to the ice rink for the host team, visiting team, as well as for the Chief Referees and Linesmen.
 - 1.13. Equipped seats at the grandstands for Mass Media representatives located close to the Press Center, room for press conferences, and staff entrance through which the Mass Media representatives enter the Sports Facility.
 - 1.14. An area at one of the central sectors (within the neutral zone of the ice rink) at the Sports Facility grandstands for at least ten (10) accredited photographers.
 - 1.15. Equipped seats at the grandstand for medical personnel on duty that shall be located close to the maintenance goal for ice-resurfacing machines.
 - 1.16. Room for the Officials' team and the Official Game Report Execution located close to the Officials' desk.
 - 1.17. Two interconnecting rooms for the Medical Station compliant with sanitary regulations and standards 2.1.3.2630-10: doctor (paramedic) room — 15 m², sanitary room — 8 m², cloakroom entrance for visitors — 4 m², toilet facilities — 3 m².
 - 1.18. Three interconnecting rooms for doping control compliant with sanitary regulations and standards 2.1.3.2630-10: waiting room — 18 m², room for medical procedures — 12 m², toilet facilities — 3 m² (toilet and washbasin). The premises shall be located in the dressing room area or close to it.
 - 1.19. Premises for the Club doctor compliant with sanitary regulations and standards 2.1.3.2630-10 and including at least the following: doctor's office — 12 m², room for medical procedures — 12 m², massage room — at least 10 m², toilet facilities — 6 m² (toilet, washbasin); and the room of the visiting team doctor (no less than 8 m²) interconnected with or close to the visiting

- team dressing room.
- 1.20. Designated seats at the grandstands (at least five (5)) for disabled people and at least five (5) seats for accompanying persons ensuring barrier-free environment and the respective passages. Such seats must be equipped with special appliances (ramps, elevators) for free movement and access of persons with disabilities related to supporting-motor system, using wheelchairs, as well as equipped with a toilet cabin for this category of people. The toilet cabin shall be equipped with a washbasin with a pedal-type mixer, a mirror above the washbasin located at the right height, hinged handrails at the flush toilet area, a paper tissue or towel container, open-type toilet paper holder or dispenser, a liquid soap container, a wastebasket. Height must be convenient for this category of people. External ramps must have handrails taking account of technical requirements for stationary supporting devices. On the territory adjacent to the Sports Facility, there must be a designated parking area for at least five cars transporting disabled people.
 - 1.21. Separate entrance to the Sports Facility to ensure the shortest route to the “away” sector for the visiting team supporters.
 - 1.22. Men’s and women’s toilets located in the “away” sector area.
 - 1.23. Public meals stations located in the “away” sector area.
 - 1.24. Access and parking areas for vehicles that are used to deliver the teams, Officials, their equipment close to the respective entrances making it possible to ensure their security.
 - 1.25. Areas for convenient access and parking of ambulance vehicles close to the respective entrances.
 - 1.26. Cloakrooms in the adjacent territory of the Sports Facility where spectators can leave their items that are prohibited to carry on to the Sports Facility.
 - 1.27. Parking areas for spectators’ cars in the territory adjacent to the Sports facility shall be organized. VIP parking area must be organized close to the VIP entrance to the Sports Facility with a convenient access for vehicles. The parking area shall provide sufficient space for the incoming vehicles and have high throughput.

**REQUIREMENTS FOR PREPARING AND USING
THE ICE SURFACE****1. Concrete slab preparation**

- 1.1. Before freezing of water, the concrete slab shall be carefully washed with clean water (from the municipal water system) without using any special household chemicals.
- 1.2. If the concrete slab is painted, two layers of frostproof dazzling-white facade acryl paint shall be used. Once the slab is completely dry, it should be cooled for creating solid ice.

2. Creating the solid ice

- 2.1. The lower ice layer must ensure adherence with the concrete wall to avoid exfoliation.
- 2.2. When creating the first ice layer, hose flooding is used with an average layer thickness of 1 mm each.
- 2.3. The average thickness of the first ice layer shall be 10–12 mm.

3. Painting the ice rink

- 3.1. If the ice rink is painted in white color, special-purpose professional paints similar in quality to Superweiss 3000, Ice Pack or Jet Ice White 3000 shall be used. After painting, protective ice layer shall be created of 10 to 12 mm thickness regarding the requirements of the paint manufacturers.

- 3.2. The ice surface must be smoothed, any traces of paint surfacing shall be taken care of.
- 3.3. Then, ice must be trimmed, and the smoothing layer shall be created.

4. Marking and advertisement

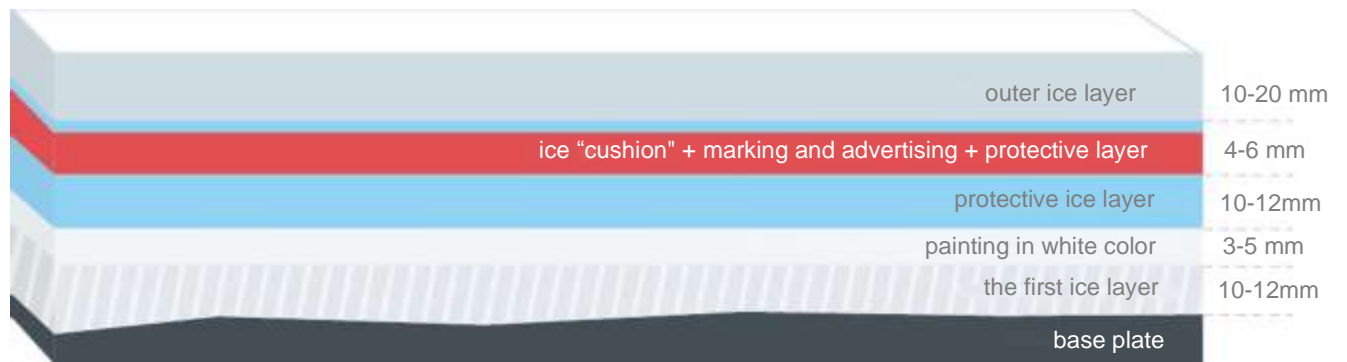
- 4.1. Marking is created on smooth ice using paint of the respective color.
- 4.2. Advertisement banners are laid and iced. Then, the banners are cut along the key drawing making sure the banner edges do not surface. Once the paint and banners have frozen, protective ice layer of at least 1.5 mm shall be created.
- 4.3. The shade of the white color of banners under the ice must be the same as the shade of paint on the ice surface using the selected color system (NCS, RAL, etc.).
- 4.4. To reduce chemical effect of the banner's material on ice, it should be thoroughly washed by water from the flooding hose without extra pressure before laying. It is expressly prohibited to scrub the banner using brushes (or other tools).
- 4.5. When selecting the in-ice banner material, a Club is recommended to test its humidity permeability, moisture-retaining power and chemical reactivity to avoid its surfacing and other negative impacts on the ice quality.
- 4.6. To increase the ice thickness to the level at which ice-resurfacing machines can move without damaging banners, hose flooding is used.
- 4.7. The remaining ice of the specialized surface shall be performed by ice-resurfacing machines.

5. Outer ice layer

- 5.1. "Water towel" shall be used during flooding by ice-resurfacing machines.
- 5.2. The outer ice layer thickness shall be 10–20 mm, while the total thickness of ice shall be no less than 35 mm and no more than 50 mm.
- 5.3. The outer ice layer shall be renewed at least three times for a season.

BOARD SYSTEM REQUIREMENTS**1. Lifetime of board systems**

- 1.1. A board system lifetime shall be no more than 12 years from the initial installation of the board system.
Board systems that have been used for 12 years must be replaced by board systems compliant with this Appendix to the KHL Technical Regulations.

- 1.2. The replacement of acryl safety shield is performed depending on its condition during the lifetime of board systems. The condition is determined by KHL inspections of Sports Facilities.
- 1.3. The acryl safety shield installed on top of the board shall be replaced depending on its condition during the lifetime. The condition is determined by KHL inspections of Sports Facilities.

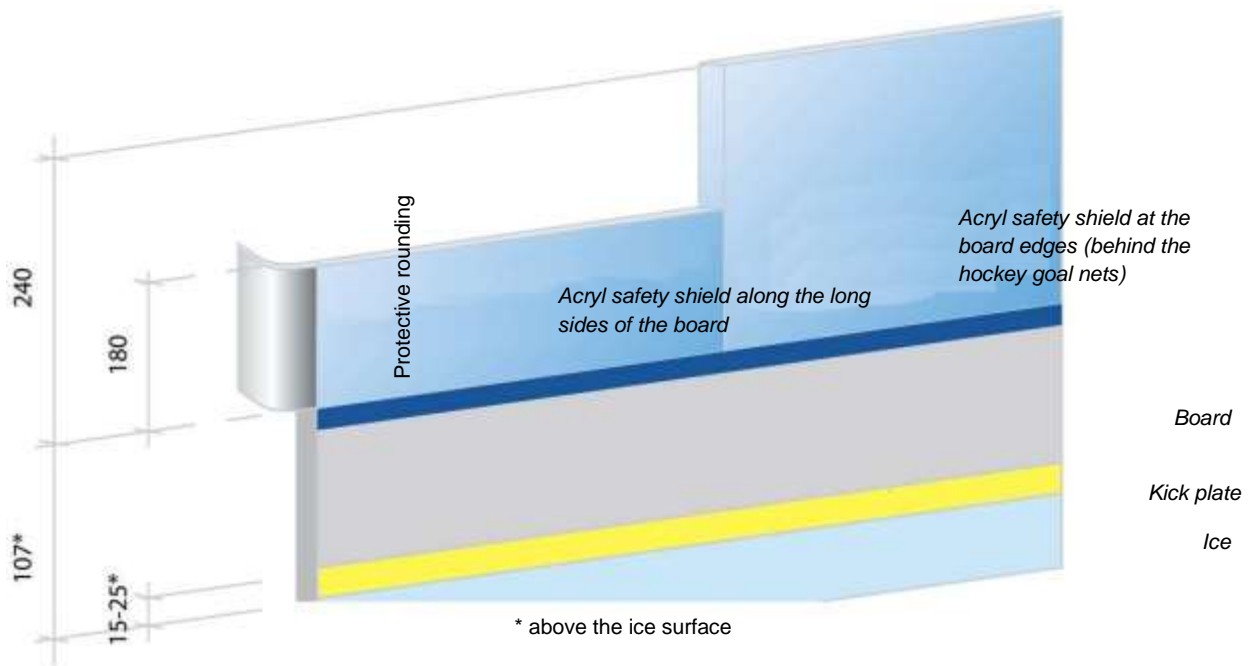
2. Ice hockey rink size

- 2.1. Maximum size is **60 m** lengthwise and **30 m** broadwise.
Starting from season 2020/21 the maximum size shall be **60 m** lengthwise and **28 m** broadwise.

- 2.2. Minimum size is **56 m** lengthwise and **26 m** broadwise.
- 2.3. The rink corners must be rounded by a radial arc with the radius of **7–8.5 m**.

3. Board

- 3.1. Board height shall be **107 cm** above the ice surface (from the ice surface to the upper horizontal plane of the shelf).
- 3.2. The board surface on the ice side must be smooth, have no cusps, roughness or obstacles that may result in Players' injuries or modify the natural puck movement.
- 3.3. In the upper part of the board alongside the entire perimeter, a shelf shall be installed to designate the border between the board and the safety shield.
- 3.4. Full size of the shelf (distance from the vertical plane of the safety shield and the shelf edge on the board surface on the ice side) shall be no more than **40 mm**. The shelf shall be rounded with a radius of at least **20 mm**. The slip (friction) factor of the shelf must be uniform with respect to the board surface and barrier elements.
- 3.5. At the board basement, a yellow kick plate shall be installed with a height of **15–25 cm** above the ice surface.
- 3.6. All doors for entering the ice rink shall be opened to the outer side of the rink.
- 3.7. The gap between the doors and the board shall be minimized to **5 mm**.
- 3.8. The board shall amortize the hit during the power physical contact.
- 3.9. The gap between the board panels shall be minimized to **3 mm**.

4. Safety shield

- 4.1. Alongside the entire perimeter of the board during the KHL Championship, a **transparent acryl safety shield** shall be installed. The shield width shall be **15 mm** and height — **180 cm** at the longer sides of the board, except for the area in front of the Players' Bench; the height **shall be 240 cm at the board edges behind the hockey goal nets** and continued along the board radius and longer sides towards the neutral zone for **4 m** off the goal line.
- 4.2. In the areas where the shield is not installed in front of the Players' Benches, a **shock-absorbing rounding of polycarbonate or acryl with the radius of 500 mm** shall be installed for protecting Players against injuries.

The acrylic safety shield and the shock-absorbing rounding of polycarbonate or acryl shall be connected throughout the height with a red strip, 80 mm wide and 1800 mm high, which is a divider of the limits of the hockey rink and the Players' bench (*Fig. 1*).

- 4.3. Gaps between safety glass shall be closed by special sections or inserts.
- 4.4. Safety shield sections are installed so that any section can be replaced without damaging the integrity of other sections.
- 4.5. The 15 mm wide acryl safety shields installed on the board shall amortize the hit during the power physical contact between Players.
- 4.6. The safety shield must prevent contacts between Hockey Players, team representatives, game Officials and spectators, as well as appearance of items thrown from the stands to Players' Benches, Penalty Boxes and game Officials.
- 4.7. It is prohibited to drill any holes in the safety shield that may result in injuring a Player or modify the natural puck movement, excluding the hole (**diameter — 10 cm**) in front of the Game Secretary for communicating with the Chief Referee of the Game.
- 4.8. Metal supporting poles are allowed in the spectator shield system only in the area of maintenance goals and doors (Penalty Box, access door).
